<u>1 056 nomination forms for Election</u> <u>Committee Subsector Ordinary Elections</u> <u>received by deadline</u>

The nomination period for the 2021 Election Committee Subsector Ordinary Elections, which began on August 6, ended at 5pm today (August 12). The Returning Officers of subsectors with members to be returned by election received a total of 1 016 nomination forms for candidates by the close of nominations, of which 23 were received today. As for subsectors with members to be returned by nomination, Returning Officers received a total of 40 nomination forms for designated bodies, of which one was received today. In other words, Returning Officers received a total of 1 056 nomination forms throughout the nomination period.

The Returning Officers will determine the order of names of candidates for their respective subsectors to be appeared on ballot papers and the allocation of the designated spots for display of election advertisements by drawing of lots at the Hong Kong Convention and Exhibition Centre on August 23 (Monday). The Candidate Eligibility Review Committee will, within 14 days after the close of nominations, publish in the Gazette a notice of validly nominated candidates. If there is a contested election for a subsector, a poll for that subsector will be held on September 19 and the number for the candidates concerned to be printed on ballot papers will also be published on the above Gazette notice.

The Electoral Affairs Commission will hold an online briefing for candidates on August 25 (Wednesday). The Commission Chairman, Mr Justice Barnabas Fung Wah, will chair the briefing and brief candidates about the guidelines on election-related activities and important points to note in running their election campaigns. A representative from the Independent Commission Against Corruption will explain the Elections (Corrupt and Illegal Conduct) Ordinance. A representative from Hongkong Post will explain the arrangement and requirements of the free postage service for election mail. Representatives from the Registration and Electoral Office and the Department of Justice will also be present.
