

66 more nomination forms for Election Committee Subsector Ordinary Elections received today

â€‹The Returning Officers for the 2021 Election Committee Subsector Ordinary Elections received a total of 63 nomination forms for candidates and three nomination forms for designated bodies today (August 10). This brings to 913 the total number of nomination forms for candidates and 38 the total number of nomination forms for designated bodies received since nominations for the Election Committee Subsector Ordinary Elections opened on August 6. The nomination period will end on August 12.

If there is contested election for a subsector, a poll will be held for that subsector on September 19.
