# Defeating Ebola in Sierra Leone conference

The conference aims to get countries and other international donors to pledge beds, medical staff and money to help end Ebola in Sierra Leone.

The Defeating Ebola in Sierra Leone pledging conference will take place on Thursday 2 October at Lancaster House, London.

The conference will highlight the scale of the Ebola crisis, build on the outcomes and momentum from the UN General Assembly and look ahead to an EU donor conference for the wider West Africa region, provisionally planned for the end of October.

The Ebola outbreak in West Africa is an unprecedented human tragedy. The UN has declared it a public health crisis requiring an urgent international response. Thousands of medical and support staff are needed and the UN has called for \$1 billion in response.

At the request of the government of Sierra Leone and under the auspices of the UN, the UK is co-ordinating the international mission in Sierra Leone to control, contain and ultimately defeat Ebola.

The government of Sierra Leone is asking friends in the international community to work with the UK in assisting millions of Sierra Leoneans in their hour of need.

"I want to personally thank all those who have contributed in large or small ways to the success of Scotland's summer of sport. Whether you are a keen fan or an accomplished athlete, an instructor or a volunteer, you have all made Scotland shine. The legacy will live on in our sports centres, on golf courses and in swimming pools across the country."



# Under the Tories Britain is facing an energy bill crisis - Caroline Flint

Caroline Flint MP, Labour's Shadow Energy and Climate Change, commenting on research from Age UK showing that 3.5 million older people are worried about keeping warm at home this winter, said:

"Under the Tories, Britain is facing an energy bill crisis, with millions of people, especially older people, struggling to heat their homes. Labour has already set out radical plans to freeze energy prices until 2017, saving the average household £120, and fix the energy market for the future, with a tough new regulator to curb rip-off bills.

"One of the main reasons our energy bills are so high is that our homes are some of the least energy efficient in Europe – leaking heat from their roofs, walls and windows. That's why Labour will end the scandal of cold homes, with five million homes upgraded in 10 years. Our plans will mean cheaper bills and warmer homes for millions."

### Billions to be invested by Scottish Water

A £3.5 billion investment by Scottish Water will ensure it continues to provide one of the best value for money water services in the UK, Deputy First Minster Nicola Sturgeon said today.

The publicly owned company is starting a six-year programme, backed by £720 million of borrowing from the Scottish Government.

The investment work will support 5,000 construction jobs and will improve drinking water supplies, protect the environment and support the economy.

Scottish Water investment projects planned include:

 More than £280 million in improvements to water mains and water treatments works across Scotland.

- Over £100 million for a Glasgow waste water tunnel to improve water quality in the River Clyde and reduce flooding in Mount Florida and Giffnock.
- £45 million to deliver solutions to around 400 external sewer flooding problems across Scotland.
- Over £60 million to reduce the impact of discharges to the River Clyde from Daldowie and Dalmarnock Wastewater Treatment Works.
- Drinking water improvements including at Glenlatterach (Aberdeenshire - £5.6 million), Fair Isle (£4.9 million) and South Uist (£6.8 million).

The Scottish Government has set out in its policy

statement that water charges must remain stable and not increase by more than the rate of inflation.

An exemption scheme will be extended to more of the charitable sector to help pay for their water and sewerage services.

Ms Sturgeon said:

"Water and sewerage services are vital to our everyday lives. It is important that we continue to invest to ensure that these keep on meeting the needs of customers, the environment and economic development.

"I recognise that households and businesses are under financial pressure. That is why I expect Scottish Water to continue to deliver this £3.5 billion investment programme without the

need for inflation-busting charge increases.

"The Government will be making available up to £720 million to support this programme. It will also be extending the assistance to more of the charitable sector to help pay for services.

"This Government is determined to ensure that Scottish Water continues to be a public sector success story. This programme is good news for customers, the construction industry and our environment."

Douglas Millican, Scottish Water's chief executive, said:

"I am delighted that we are announcing the start of this major investment programme for 2015-21 which will enable Scottish Water to continue to provide first-class customer service, while supporting the Scottish economy and creating jobs in the construction industry.

"We look forward to working closely with our customers and communities to further improve drinking water quality and the environment the length and breadth of Scotland."

# Driving forward action on climate change

The Scottish Government's Cabinet Sub-Committee (CSC-CC) on Climate Change has held its first meeting.

The group, chaired by Environment Secretary Richard Lochhead, discussed what action the Scottish Government is taking to tackle climate change – and how it can drive forward efforts to ensure Scotland remains on track to meet its world-leading climate change ambitions.

### 54,000 homeowners created through Help to Buy

The Help to Buy schemes have created over 54,000 homeowners in England Housing Minister Brandon Lewis announced today (30 October 2014).

The new figures show how Help to Buy is helping more and more people onto the property ladder and getting more homes built, with over 39,000 households buying new-built properties through the equity loan and NewBuy options, and 15,000 households buying through the mortgage quarantee.

A further 3,400 new homeowners have been created in Scotland, Wales and Northern Ireland through the Help to Buy: mortgage guarantee. Help to Buy increases house building House building and the Help to Buy schemes are key parts of the government's long-term economic plan.

Around 8 out of 10 sales went to first time buyers and as a direct result thousands of new home owners were created and private house building starts rose by a third.

House building has climbed to the highest level since 2007, construction output has seen the sharpest expansion for 8 months, and companies are now taking on workers at the fastest rate since 1997.



### SNP risks creating criminals with new drinkdriving limit

The Scottish Government risks creating criminals and getting its priorities badly wrong with the introduction of its new drink-driving limit, it has been warned.

It was announced this morning that the lower threshold – which could see someone fail a breathalyser test with only a single drink – will be introduced before Christmas.

Under the controversial plans, the limit will be reduced to only 50mg in every 100ml of blood, compared to the current level of 80 mg.

The Scottish Conservatives have criticised the move, saying it will criminalise a wide range of people who are currently hardworking, law-abiding citizens.

The party would prefer police to focus their limited resources on those are at the more serious end of the drink-driving scale.

Neither the police nor the Scottish Government have been able to publish statistics showing how many accidents have been caused by those with between 50 and 80 mg in their blood.

Scottish Conservative transport spokesman Alex Johnstone MSP said:

"The view of many people is we should focus resources on people who are three, four or even five times the legal limit.

"But with this move, the risk is police will stop chasing

maniacs on a Saturday night who are inebriated behind the wheel, and instead target young mothers in supermarket carparks on Sunday mornings.

"It would be a huge mistake for police to switch their focus to those who are between the new limit and the existing limit.

"But of course, they will be the easy ones to target, because they won't object, they'll pay their fines, and make a lot of money for the state in the process.

"This reduction risks creating criminals of people who are perfectly law-abiding, hardworking individuals, while reducing the spotlight on those who are truly dangerous drivers."

# Number of workless households in Wales falls

The number of households where no one has a job fell in all but four of the 22 local authorities in Wales between 2012 and 2013.

According to analysis published this week by the Office of National Statistics, Cardiff, Swansea, Neath and Port Talbot saw the biggest reductions in the percentage of workless households whilst Newport, Isle of Anglesey, Blaenau Gwent and Torfaen were the only areas to see an increase.

This analysis covers a period when there were 188,000 workless households in Wales; however more recent statistics published last week showed that the number of "workless households" in Wales had fallen by 43,000 since June 2010 to 183,000 by June this year.

Secretary of State for Wales Stephen Crabb said:

Creating jobs and giving people the satisfaction of earning a regular wage is part of our long term economic plan for Wales. Last week's figures show that our plan is working but the true measure of success is that this is happening right across the whole country and whilst there are still some areas where we need to do more, this analysis from 2013 is extremely encouraging.

Since the war, there has been a steady decline in manufacturing employment but a continuing rise in manufacturing output.

Growth in technological advancement has enabled

greater production using fewer workers who are generally more highly skilled.

The mass employment of workers performing labour-intensive and repetitive tasks has largely been replaced by machines or out sourced to 'offshore resources' such as China and India where manpower, products and components can be cheaply supplied.

Whilst it could be argued that it's 'all built in China now', the UK still maintains its lead as a high-end manufacturer and is the sixth largest manufacturer in the world. The danger lies in these offshore resources 'squaring the circle' by producing highly skilled workers manufacturing high-end products of their own.

It is in fact the initiation and control of the full process that we need to pass on to future generations in order for the UK to continue to maintain and grow its skill base. Outsourcing will be detrimental to the future of our trades if it means using the skills of trained workers elsewhere, leading to the inevitable brain drain as home grown talents are forced to seek opportunities abroad.




### Intellectual property - Cost of loss and theft



However, a patent is only enforceable in the participating country or countries specified within the patent application. Many countries do not enforce or recognise patent protection law and allow the large scale copying of designs and goods to be carried out unabated.

Theft of intellectual property is on the increase and even small companies now have to protect themselves from attack from industrial espionage with cyber crime costing the UK more than £27bn a year.





# Vaccinate toddlers against flu advises Chief Medical Officer

Healthy under-5s are more likely to be admitted to hospital with flu than any other age group – and 5 times more likely than 65-year-olds.

Two million 2, 3 and 4-yearolds are eligible for the free nasal spray flu vaccine from their GP.

Analysis shows that vaccinating half of all children aged between six months and four would prevent almost half a million cases of flu.

But just over a quarter have received it so far – fewer than this time last year. And half of parents do not know the free spray exists or that children need vaccinating every year.

Flu leads to hundreds of thousands of GP visits and tens of thousands of hospital stays a year.

Young children are more likely to spread flu because they tend to have greater contact with others, and may not cover their mouths when coughing and sneezing or wash their hands enough.

There are more than 15 million people in England with at least one long-term health condition and they are 11 times more likely to die if they catch the virus.

The nasal spray vaccine offers the best protection for children and the only likely side effect is a slight runny nose for a short time. This year the free vaccine was extended to 4-year-olds and the aim is to gradually roll it out to all 2 to 16 year olds.

Groups eligible for free flu vaccinations on the NHS

#### are:

- children aged 2, 3 and 4.
- pregnant women
- under 65s with long-term conditions
- over 65s

Chief Medical Officer, Professor Dame Sally Davies, said:

Flu can be really nasty for toddlers, leading to time off nursery which has a big impact on mums and dads and sometimes even a stay in hospital.

They also spread the virus easily and often pass flu to grandparents and other relatives who can become very ill, fast.

Giving 2, 3 and 4 year olds the free nasal spray really is in everyone's interests if you want to help avoid a miserable winter for all the family.



# NHS volunteers deployed to fight Ebola in Sierra Leone

More than 30 NHS staff from across the UK will depart for Sierra Leone on 22 November 2014 to join Britain's fight against Ebola, International Development Secretary Justine Greening and Health Secretary Jeremy Hunt have announced.

They are the first group of NHS volunteers to be deployed by the UK government. After arriving in the capital, Freetown, early tomorrow morning where they will complete a week of training before moving to British-built Ebola treatment centres across the country.

Following this training and acclimatisation the group, which includes GPs, nurses, clinicians, psychiatrists and consultants in emergency medicine, will then begin work setting up procedures, diagnosing and treating people who have contracted the deadly virus.

They will work in treatment centres built by British Army Royal Engineers and funded by the Department for International Development.

Justine Greening said:

Our fight against Ebola in West Africa is one of Britain's biggest responses to a disease outbreak. Almost a thousand military personnel, scientists, healthcare and aid workers are already on the ground in Sierra Leone working to contain, control and defeat this terrible disease.

But to beat Ebola we desperately need the

experience and dedication of skilled doctors and nurses to care for the thousands of sick and dying patients who are not receiving the treatment they need.

Every one of these NHS heroes will play a vital role in the fight against Ebola. It is only because of their combined efforts that we stand a chance of defeating this disease.

# Labour to demand government gets a grip of DWP chaos

Rachel Reeves MP, Labour's Shadow Work and Pensions Secretary, speaking ahead of a Commons debate (Monday 30 June 2014) on the chaos within the Department for Work and Pensions, said:

### Harnessing Scotland's wave power

Scotland is to establish a wave energy technology development body to encourage innovation in the industry Minister for Business, Energy and Tourism Fergus Ewing has announced.

'Wave Energy Scotland' will bring together the best engineering and academic minds to collaborate in a research and development programme to accelerate wave technology further.

Mr Ewing will provide more detail on Wave Energy Scotland during a Parliamentary statement on marine energy which he plans to make next week.

The Scottish Government recognises that early stage technologies, such as wave energy, can take time to flourish.

The development of wave energy has also been hampered by the uncertainty facing the energy sector more widely, following the lengthy and delayed changes to the electricity market resulting from the UK Government's Electricity Market Reform process.

Given that uncertainty, it is not surprising that investors are presently reluctant to commit to higher risk marine technologies. In spite of generous support for the sector from the Scottish Government, the lack of private capital has seriously hampered the progress of both wave and tidal energy developers.

Fergus Ewing said:

"With the extraordinary ocean energy resources off Scotland's coasts,

our belief in the future success of wave energy is undiminished.

"Now is the right time to consider the future of our support for wave energy in Scotland. This is a young industry and we still have a lot of learning to do in marine renewables.

"We want to encourage further innovation in wave energy development and we recognise the need for a bold new approach to supporting this emerging technology. There is also a lack of design convergence in wave energy with many different concepts in development, while tidal appears to be converging on a front-runner design.

"With Wave Energy Scotland, we are proposing a fresh and collaborative way to accelerate wave technology development.
The best minds in industry and academia will work together to develop technologies that can be commercialised by the private sector.

"The Scottish Government and its enterprise bodies are absolutely committed to supporting the development of the wave and tidal sectors to unlock the potential of our seas.

"Marine energy is an important part of our renewable energy portfolio offering real economic opportunities for Scotland.

"This means that while the tidal energy sector is ready to build array demonstration projects – the MeyGen project in the Pentland Firth is one such example – the wave energy sector must evolve further to gain the confidence of investors."

# Weeding out non-native invasive species in Cambridgeshire

Maintenance teams are more than half way through a 6-week programme, removing the invasive nonnative species (INNS) to try to stop it spreading further.

Using floating weed harvesters and lifters, the Environment Agency teams have removed more than 1000 tonnes of wet cut invasive weed, while another team followed up behind, hand removing and spraying the smaller pieces of weed.

Floating Pennywort is normally found in tropical aquaria and garden ponds. It is, however, being found more and more in rivers across the country.

It forms very dense mats of vegetation which can grow rapidly (up to 20 centimetres per day) out from the riverbanks.

These mats have the potential to cause serious problems for fish and anglers by suffocating fish and preventing access to the water.

The plant also obstructs movements of animals and boats, restricting navigation and recreational use of watercourses.

Darren Trumper, Environment Agency Operations Delivery Team Leader said:

Floating Pennywort has become a major problem for us all in the River Cam and Ely Ouse.

Some of the Floating Pennywort mats we

are removing from the riverbanks along the Ely Ouse are 22 metres long and 10 metres wide, and can be a depth size of about 30 millimetres. In one location the teams removed a mat weighing 1.7 tonnes!

An especially worrying factor in the infestation is the invasion of the River Cam Washes, which is a Site of Special Scientific Interest (SSSI) and crucial to all kinds of wildlife.

The rivers and its tributaries in our area provide the perfect breeding ground for Floating Pennywort which has formed dense mats. These block out oxygen and light in what was very good aquatic habitats for fish, and native plants. It also deprives birds and

creatures from feeding from the waters.

Native to North America, Floating Pennywort is a fast growing invasive species of freshwater plant. It is widespread and well established in the south and east of England and appears to be spreading rapidly north and westwards.

As such, this makes it one of many high priority invasive non-native plant species in Great Britain.
