#### <u>Second phase of Drug Refill Services</u> <u>E-Fill rolled out</u>

The following is issued on behalf of the Hospital Authority:

The Hospital Authority (HA) launched the Drug Refill Services E-Fill pilot programme at Prince of Wales Hospital (PWH) and Tuen Mun Hospital (TMH) in December 2017. Under the programme, patients' prescriptions are split into smaller and manageable quantities, while pharmacists review and reaffirm the latest condition of the patients before each refill. Phase two of the pilot programme will be rolled out at Pamela Youde Nethersole Eastern Hospital (PYNEH) starting from today (December 27).

Medical Specialist Out-patient Clinic (SOPC) patients of PYNEH aged 60 or above who are typically prescribed with drug items for an extended period, such as over 16 weeks until the next consultation, will join the second phase of the pilot programme. These patients will be informed and given prescription slips with refill schedules during their upcoming SOPC consultation sessions. Reminders via telephone calls or short message service (SMS) will be sent to patients three to five days prior to the scheduled refill date. Patients or their carers can collect refill medications using the "Refill Prescription Coupons" at designated counters of the hospital's 24-hour pharmacy department.

Special telephone or face-to-face counselling sessions will be arranged by pharmacists for patients with complex situations, such as hospital readmission, cross-specialty consultations or when there is a need to adjust the prescriptions.

"The first phase of the Drug Refill Services E-Fill pilot programme was implemented in PWH and TMH about one year ago. Around 20 000 patients were covered by the programme and feedback was generally positive. By adjusting the prescriptions for patients, wastage due to surplus drug can be reduced, besides preventing confusion due to overstocking of drugs. It is estimated that the second phase of the pilot programme could cover 5 000 patients," said the HA Chief Pharmacist, Ms Anna Lee.

The HA will continue to improve the operation workflow of E-Fill and roll out the programme to more public hospitals. The implementation of E-Fill is aimed at enhancing high-risk patients' drug compliance and safety, minimising the possibility of confusion and inappropriate use of drugs, and avoiding the storage of excess quantities of drugs.

In addition to Hong Kong Park, the 20th phase of the Arts Corner at Victoria Park will run from April 5 next year to March 29, 2020, and will be open from 10am to 6pm on Sundays and public holidays at the park's South Pavilion Plaza. Individuals or non-profit making organisations (any charitable organisation which is exempt from tax under section 88 of the Inland Revenue Ordinance) who are interested in operating the stalls in this new round of the Victoria Park Arts Corner are welcome to submit applications between January 2 and 23 next year. ### Hong Kong Customs seizes suspected cocaine (with photo)

Hong Kong Customs seized about 1.35 kilograms of suspected cocaine with an estimated market value of about \$1.51 million at the Hong Kong International Airport yesterday (December 25).

A 41-year-old female passenger arrived in Hong Kong from Johannesburg, South Africa yesterday morning. During Customs clearance, one packet of suspected cocaine with a weight of about 1.35 kilograms was found being packed on her body.

The woman was then arrested.

The arrested woman was charged with one count of trafficking in a dangerous drug. She will appear at West Kowloon Magistrates' Courts tomorrow (December 27).

Under the Dangerous Drugs Ordinance, trafficking in a dangerous drug is a serious offence. The maximum penalty upon conviction is a fine of \$5 million and life imprisonment.
