

Government finishes exercise on “restriction-testing declaration” in respect of specified “restricted area” in Tai Po and enforcement operation for breaches of compulsory testing notice (with photo)

The Government yesterday (February 1) exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" effective from 6pm yesterday, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Tai Po (i.e. Serenity Villa, Tai Po Tau, Tai Po) were required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing were required to stay in their premises until all such persons identified in the "restricted area" had undergone testing and the test results were mostly ascertained. Moreover, the Government issued a compulsory testing notice yesterday, requiring persons who had been present at the above buildings for more than two hours from January 19 to February 1, 2022, even if they were not present in the "restricted area" at the time when the declaration took effect, to undergo compulsory testing on or before February 3, 2022. The Government announced the completion of the compulsory testing exercise at around 10am today (February 2) and carried out enforcement action in the "restricted area" afterwards to verify that all people in the "restricted area" had undergone compulsory testing in accordance with the requirements of the relevant declaration and compulsory testing notice. The Government announced that the enforcement operation ended at around 11.30am today.

In this exercise, the Environment Bureau, the Civil Service Bureau, the Environmental Protection Department, the Home Affairs Department (including the Tai Po District Office), the Hong Kong Police Force, the Food and Environmental Hygiene Department and the Tobacco and Alcohol Control Office of the Department of Health mobilised around 160 staff to arrange for implementation of the declaration and enforcement actions for breaches of the compulsory testing notice issued earlier.

The Government thanks persons subject to compulsory testing for their support and understanding. With everyone's co-operation and efforts, coupled with the tireless efforts of the testing contractors, residents have been informed about their testing results by SMS notification. After finishing the compulsory testing exercise at around 10am today, the Government took enforcement action in the "restricted area" immediately to verify that all people in the "restricted area" had undergone testing according to the

requirements of the declaration and the compulsory testing notice. Persons who could present an SMS notification containing a negative testing result or wore a wristband as proof of having undergone the compulsory testing could leave the "restricted area" through the designated exit after providing personal information to a prescribed officer. The enforcement operation was completed at around 11.30am. Test records of around 130 persons subject to compulsory testing were checked. Nine persons were found not having undergone compulsory testing and compulsory testing order was issued to them. Taking into account the above situation, the Secretary for Food and Health revoked the "restriction-testing declaration" in accordance with Cap. 599J (see attachment).

The Government reminds the 14 households who have not answered the door to contact the Government for arrangement of testing as soon as possible after reading the notices put up by the Government, in the hope of eliminating the possible risk of further spread of the virus in the community.

The Government thanks all participating government staff and the testing agencies for their hard work. The Government is also grateful to those subject to compulsory testing for their support and understanding, and their full co-operation during this period in undergoing testing and waiting for the results at home.

The Government will seriously follow up on the compliance situation of the compulsory testing notices and the "restriction-testing declaration" by persons subject to compulsory testing. Any person who fails to comply with the compulsory testing notices commits an offence and may be liable to a fixed penalty of \$5,000. The person will also be issued with a compulsory testing order, requiring him or her to undergo testing within a specified time frame. Failure to comply with the order or the "restriction-testing declaration" is an offence and the offender may be liable to a fine of level 4 (\$25,000) and imprisonment for six months.

The Government yesterday (February 1) exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" effective from 6pm yesterday, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Tai Po (i.e. Serenity Villa, Tai Po Tau, Tai Po) were required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing are required to stay in their premises until all such persons identified in the "restricted area" have undergone testing and the test results are mostly ascertained. In addition, the Government issued a compulsory testing notice yesterday to any person who had been present at the above buildings for more than two hours from January 19 to February 1, 2022, to undergo compulsory testing on or before February 3, 2022, even if they were not present in the "restricted area" at the time when the declaration took effect. The Government finished the compulsory testing exercise at around 10am today (February 2) and is now carrying out enforcement actions in the "restricted area" to verify that all people in the "restricted area" have undergone compulsory testing. The Government will further announce the revocation time of the declaration.

Starting from around 10am today, persons in the specified "restricted area" in Tai Po who have undergone testing and are able to present SMS notifications with negative test results or wear wristbands as proof of having undergone testing may leave the "restricted area" through the designated exit after providing personal information to a prescribed officer.

The Government set up temporary specimen collection stations in the "restricted area" yesterday and requested persons subject to compulsory testing to collect combined nasal and throat swab samples at the stations to undergo a COVID-19 virus test before 11pm yesterday. 634 people within the area had undergone testing, among which three cases tested preliminarily positive were found. The Centre for Health Protection of the Department of Health will arrange to follow up.

Moreover, the Government also assigned staff to visit 197 households within the "restricted area", among which 14 households did not answer the door. The Government will take measures to follow up.

The Government reiterates that enforcement actions will be taken

seriously. Any person who fails to present an SMS notification with a test result or wear a wristband as proof of having undergone testing breaches the compulsory testing notice and may be liable to a fine of \$5,000. The person will also be issued with a compulsory testing order, requiring him/her to undergo testing within a specified time frame. Failure to comply with the compulsory testing order or the "restriction-testing declaration" is an offence and the offender may be liable to a fine of level 4 (\$25,000) and imprisonment for six months.



[Working Family and Student Financial Assistance Agency staff member tests preliminarily positive for COVID-19](#)

The Working Family and Student Financial Assistance Agency (WFSFAA) today (February 2) said that a staff member of the Working Family Allowance Office tested preliminarily positive for COVID-19.

The staff member works on 7/F, 181 Hoi Bun Road, Kwun Tong. She had no contact with the public in her daily work and last went to work on January 27. She had been wearing a mask at work and followed relevant disease prevention measures.

The WFSFAA will arrange for all staff of that floor to undergo testing and work from home until the test result is ascertained. It will arrange thorough cleaning and disinfection at the premises concerned and maintain close liaison with the Centre for Health Protection of the Department of Health in taking appropriate follow-up actions.

The WFSFAA will continue to strictly implement various disease prevention measures. Staff members are reminded to pay attention to personal hygiene and stay vigilant at all times. They should seek medical advice immediately and inform the WFSFAA if they feel unwell.

Government finishes exercise on “restriction-testing declaration” in respect of specified “restricted area” at Tai Hang Tung Estate in Sham Shui Po and enforcement operation for breaches of compulsory testing notice (with photo)

The Government yesterday (February 1) exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" effective from 8pm yesterday, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Sham Shui Po (i.e. Tung Moon House, Tai Hang Tung Estate, 83 Tai Hang Tung Road, Sham Shui Po, excluding Heep Hong Society Supportive Learning Project, Hong Kong Scout 10th Kowloon Group, and Hong Kong Single Parents Association Wai Yin Association Activity and Resource Centre on G/F) were required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing were required to stay in their premises until all such persons identified in the "restricted area" had undergone testing and the test results were mostly ascertained.

Moreover, the Government issued a compulsory testing notice yesterday, requiring persons who had been present at the above buildings for more than two hours from January 18 to February 1, even if they were not present in the "restricted area" at the time when the declaration took effect, to undergo compulsory testing on or before February 3. The Government announced the completion of the compulsory testing exercise at around 7.45am today (February 2) and carried out enforcement action in the "restricted area" afterwards to verify that all people in the "restricted area" had undergone compulsory testing in accordance with the requirements of the relevant declaration and compulsory testing notice. The Government announced that the enforcement operation ended at around 9.30am today.

In this exercise, the Housing Department, the Hong Kong Police Force and the Tobacco and Alcohol Control Office of the Department of Health mobilised around 180 staff to arrange for implementation of the declaration and enforcement actions for breaches of the compulsory testing notice issued earlier.

The Government provided simple food for persons subject to compulsory

testing, including canned food, instant noodles and corn kernels, so as to facilitate the dinner arrangements of some persons subject to compulsory testing. One box of masks was also provided to each person subject to compulsory testing to help them fight against the virus.

The Housing Department set up a hotline for people restricted by the declaration to make enquiries and seek assistance.

The Government thanks persons subject to compulsory testing for their support and understanding. With everyone's co-operation and efforts, coupled with the tireless efforts of the testing contractors, residents have been informed about their testing results by SMS notification. After finishing the compulsory testing exercise at around 7.45 am today, the Government took enforcement action in the "restricted area" immediately to verify that all people in the "restricted area" had undergone testing according to the requirements of the declaration and the compulsory testing notice. Persons who could present an SMS notification containing a negative test result as proof of having undergone the compulsory testing could leave the "restricted area" through the designated exit after providing personal information to a prescribed officer.
