Government finishes exercise on
"restriction-testing declaration" in
respect of specified "restricted area"
at Ying Kwai House in Kwai Chung
Estate and enforcement operation for
breaches of compulsory testing notice

The Government exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) on January 21 to make a "restriction-testing declaration" effective from 4am on January 22, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Kwai Chung (i.e. Ying Kwai House, Kwai Chung Estate) were required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing were required to stay in their premises until all such persons identified in the "restricted area" had undergone testing and the test results were mostly ascertained. Those who have visited Ying Kwai House in the past two weeks for more than two hours should undergo testing on January 28 in accordance with the compulsory testing notice issued earlier. The Government announced the completion of the compulsory testing exercise at around 7am today (January 29) and carried out enforcement action in the "restricted area" afterwards to verify that all people in the "restricted area" had undergone compulsory testing in accordance with the requirements of the relevant declaration and compulsory testing notice. The Government announced that the enforcement operation ended at around 10am today.

In this exercise, the Housing Department, the Kwai Tsing District Office, the Hong Kong Police Force, the Department of Health, the Auxiliary Medical Service and the Social Welfare Department mobilised around 260 staff to arrange for implementation of the declaration and enforcement actions for breaches of the compulsory testing notice issued earlier.

During the effective period of the relevant declaration and compulsory testing notice, the Government delivered breakfast, lunch and dinner to persons subject to compulsory testing and provided simple food for them, including canned food, instant noodles and corn kernels, so as to facilitate their meal arrangements. In addition, the Government also provided antiepidemic items like face masks for persons subject to compulsory testing.

The Housing Department set up a hotline for people restricted by the declaration to make enquiries and seek assistance.

The Government thanks persons subject to compulsory testing for their support and understanding. With everyone's co-operation and efforts, coupled with the tireless efforts of the testing contractors, residents have been informed about their testing results by SMS notification. After finishing the compulsory testing exercise at around 7am today, the Government took enforcement action in the "restricted area" immediately to verify that all people in the "restricted area" had undergone testing according to the requirements of the declaration and the compulsory testing notice. Persons who could present a SMS notification containing a negative test result or wore a wristband as proof of having undergone the compulsory testing could leave the "restricted area" through the designated exit after providing personal information to a prescribed officer. The enforcement operation was completed at around 10am. Test records of 951 persons subject to compulsory testing were checked. Nobody was found to have not undergone compulsory testing. Taking into account the above situation, the Secretary for Food and Health revoked the "restriction-testing declaration" in accordance with Cap. 599J (see attachment).

The Government reminded the households who showed no response to contact the Government for arrangement of testing as soon as possible after reading the notices put up by the Government, in the hope of eliminating the possible risk of further spread of the virus in the community.

The Government thanks all participating government staff and the testing agencies for their hard work. The Government is also grateful to those subject to compulsory testing for their support and understanding, and their full co-operation during this period in undergoing testing and waiting for the results at home.

The Government will seriously follow up on the compliance situation of the compulsory testing notices and the "restriction-testing declaration" by persons subject to compulsory testing. Any person who fails to comply with the compulsory testing notices commits an offence and may be liable to a fixed penalty of \$5,000. The person will also be issued with a compulsory testing order, requiring him or her to undergo testing within a specified time frame. Failure to comply with the order or the "restriction-testing declaration" is an offence and the offender may be liable to a fine of level 4 (\$25,000) and imprisonment for six months.



A male police sergeant preliminarily tested positive for COVID-19

A 36-year-old male police sergeant who is posted to the Police Headquarters, preliminarily tested positive for COVID-19. He visited his family members in Kwai Chung Estate on January 20 and was arranged for COVID-19 test. He was preliminarily tested positive for COVID-19 yesterday (January 28). He has no travel history in the past 14 days. He wore face masks during his tour of duty. His last working day was January 19.

Police are highly concerned and have the following messages:

- (1) While awaiting further assessment and recommendation by the Department of Health (DH), all police officers and civilian staff who might have been in contact with the officer concerned have been arranged to undergo COVID-19 test as instructed by the DH;
 - (2) All facilities in the office concerned have been sterilised;
- (3) All officers have been reminded to reduce social contact to minimise risks of infection, and to pay attention to physical health. If feeling unwell, they should consult a doctor and report the case immediately;
- (4) Police will deploy resources flexibly to ensure provision of policing services of the areas concerned remains unaffected.

Police will maintain close communication with the DH and provide assistance in tracing the pathology, by proactively providing information such as the duty record and roster of the officer concerned. Arrangements will be made for close contacts to be conveyed to quarantine centres to undergo quarantine.

Government finishes exercise on "restriction-testing declaration" in respect of specified "restricted area" at Ha Kwai House in Kwai Chung Estate

and enforcement operation for breaches of compulsory testing notice (with photo)

The Government earlier exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration", under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Kwai Chung (i.e. Ha Kwai House, Kwai Chung Estate) are required to stay in their premises and undergo compulsory testing. The declaration has been effective from 7pm, January 24. The Government extended the period of operation on January 25 and aimed at finishing the exercise at about 7am today (January 29). Persons subject to compulsory testing are required to stay in their premises and undergo five tests under the designated arrangement (including those conducted in the past few days under the declaration), until all such persons identified in the "restricted area" have undergone testing and the test results are mostly ascertained, and upon the agreement of the Secretary for Food and Health having regard to all the circumstances and the public interest of Hong Kong. The Government finished the compulsory testing exercise at around 7am today and carried out enforcement action in the "restricted area" afterwards to verify that all people in the "restricted area" had undergone compulsory testing in accordance with the requirements of the relevant declaration and compulsory testing notice. The Government announced that the enforcement operation ended at around 10am today.

In this exercise, the Housing Department, the Kwai Tsing District Office, the Tsuen Wan District Office, the Hong Kong Police Force, the Food and Environmental Hygiene Department, the Leisure and Cultural Services Department, the Electrical and Mechanical Services Department, the Social Welfare Department and the Auxiliary Medical Service mobilised around 1 286 staff to arrange for implementation of the declaration and enforcement actions for breaches of the compulsory testing notice issued earlier.

The Government delivered breakfast, lunch and dinner boxes to persons subject to compulsory testing and provided simple food for them, including canned food and instant noodles, so as to facilitate the meal arrangements of persons subject to compulsory testing. One box of masks was also provided to each person subject to compulsory testing to help them fight against the virus.

The Housing Department set up hotlines 2751 4421 / 2751 4424 / 2751 4428 for people restricted by the declaration to make enquiries and seek assistance.

The Government thanks persons subject to compulsory testing for their support and understanding. With everyone's co-operation and efforts, coupled

with the tireless efforts of the testing contractors, residents have been informed about their testing results by SMS notification. After finishing the compulsory testing exercise at around 7am today, the Government took enforcement action in the "restricted area" immediately to verify that all people in the "restricted area" had undergone testing according to the requirements of the declaration and the compulsory testing notice. Persons who could present an SMS notification containing a negative test result could leave the "restricted area" through the designated exit after providing personal information to a prescribed officer. The enforcement operation was completed at around 10am. Test records of 579 persons subject to compulsory testing were checked. No person was found to have not undergone compulsory testing. Taking into account the above situation, the Secretary for Food and Health revoked the "restriction-testing declaration" in accordance with Cap. 599J (see attachment).

The Government reminded the households who have not answered the door to contact the Government for arrangement of testing as soon as possible after reading the notices put up by the Government, in the hope of eliminating the possible risk of further spread of the virus in the community.

The Government thanks all participating government staff and the testing agencies for their hard work. The Government is also grateful to those subject to compulsory testing for their support and understanding, and their full co-operation during this period in undergoing testing and waiting for the results at home.

The Government will seriously follow up on the compliance situation of the compulsory testing notices and the "restriction-testing declaration" by persons subject to compulsory testing. Any person who fails to comply with the compulsory testing notices commits an offence and may be liable to a fixed penalty of \$5,000. The person will also be issued with a compulsory testing order, requiring him or her to undergo testing within a specified time frame. Failure to comply with the order or the "restriction-testing declaration" is an offence and the offender may be liable to a fine of level 4 (\$25,000) and imprisonment for six months.



<u>Service arrangements for Community</u> <u>Vaccination Centres during Lunar New</u> <u>Year period</u>

The 14 Community Vaccination Centres (CVCs) under the COVID-19 Vaccination Programme will be closed from Monday (January 31) to February 2.

Except for the two CVCs located at private hospitals which will resume its services on the fourth day of the Lunar New Year (February 4), the other 12 CVCs will resume their services on the third day of the Lunar New Year (February 3) to enable more members of the public to get vaccinated as soon as possible.
