

CHP reminds public on precautions against heat stroke during very hot weather

The Centre for Health Protection (CHP) of the Department of Health (DH) today (July 13) reminded members of the public, particularly those undertaking outdoor activities, to take heed of necessary measures against heat stroke and sunburn in very hot weather.

"The public should carry and drink plenty of water to prevent dehydration while engaging in outdoor activities," a spokesman for the CHP said.

"Those engaged in strenuous outdoor activities should avoid beverages containing caffeine, such as coffee and tea, as well as alcohol, as they speed up water loss through the urinary system," the spokesman explained.

"Infants and children, the elderly, pregnant women, those with chronic illnesses such as heart disease or high blood pressure, outdoor/manual workers, and individuals who are overweight are more vulnerable to heat stroke. They should pay special attention," the spokesman added.

The public should adopt the following precautions:

- Wear loose and light-coloured clothing to reduce heat absorption and facilitate sweat evaporation and heat dissipation;
- Avoid vigorous exercise and prolonged activities like hiking or trekking as heat, sweating and exhaustion can place additional demands on the physique;
- Perform outdoor activities in the morning or the late afternoon, if possible;
- For indoor activities, open all windows, use a fan or use air-conditioning to maintain good ventilation;
- Do not stay inside a parked vehicle; and
- Reschedule work to cooler times of the day if feasible. If working in a hot environment is inevitable, introduce shade in the workplace where practicable. Start work slowly and pick up the pace gradually. Move to a cool area for rest at regular intervals to allow the body to recuperate.

â€‹The public should also note the latest and the forecast Ultraviolet (UV) Index released by the Hong Kong Observatory (HKO). When the UV Index is high (6 or above):

- Minimise direct exposure of the skin and the eyes to sunlight;
- Wear long-sleeved and loose-fitting clothes;

- Wear a wide-brimmed hat or use an umbrella;
- Seek a shaded area or put on UV-blocking sunglasses;
- Apply a broad-spectrum sunscreen lotion with a minimum sun protection factor (SPF) of 15, preferably higher. Reapply every two hours if you stay out in the sun, and after swimming, sweating or towelling off; and
- While using DEET-containing insect repellents for personal protection against mosquito-borne diseases, apply sunscreen first, then insect repellent.

â€œIf symptoms develop, such as dizziness, headache, nausea, shortness of breath or confusion, rest and seek help immediately, and seek medical advice as soon as possible.

[24th Plenary of Hong Kong/Guangdong Co-operation Joint Conference held in Guangzhou \(with photos/videos\)](#)

The Chief Executive of the Hong Kong Special Administrative Region (HKSAR), Mr John Lee, leading the delegation of the HKSAR, met with the Secretary of the CPC Guangdong Provincial Committee, Mr Huang Kunming, and co-chaired the 24th Plenary of the Hong Kong/Guangdong Co-operation Joint Conference with the Governor of Guangdong Province, Mr Wang Weizhong, in Guangzhou today (July 12).

The Guangdong-Hong Kong-Macao Greater Bay Area (GBA) holds strategic importance in the country's new development pattern. During his inspection tour to Guangdong in April last year, President Xi Jinping stressed that "the GBA must be developed as a strategic fulcrum of the new development pattern, a demonstration zone of high-quality development, and a pioneer of Chinese modernisation", thereby setting the direction for taking forward the development of the GBA.

Mr Lee remarked, "Guangdong has all along been the most important partner of Hong Kong in regional co-operation with the Mainland. Hong Kong and Guangdong have a multi-disciplinary, in-depth and all-round co-operation relationship. In the past year, the communication and exchanges between the two sides have become closer, exchange visits at different levels have become

has been implemented since July 2023 and has been well-received by Hong Kong citizens. Currently over 65 000 Hong Kong private cars have participated in the Scheme. The vehicular flow of the Hong Kong-Zhuhai-Macao Bridge (HZMB) has been on the rise, reaching a daily average of 12 000 vehicles, representing an increase of more than 100 per cent as compared to the same period last year, among which vehicles under the Scheme account for about 40 per cent. The customs guarantee-free policy announced by the State Council in 2022 has simplified the application procedures and reduced handling fees for the Scheme, thereby increasing its attractiveness. The HKSAR Government is deeply grateful to the Central Government and the Guangdong Provincial Government for their strong support for the Scheme all along. The HKSAR Government will continue to work closely with the Guangdong Provincial Government to implement enhancement measures, continue to enhance the port facilities, and step up publicity to guide travellers to travel during non-peak hours. The implementation of the Scheme plays an important role in making better use of the HZMB and promoting inter-connectivity in the GBA.

The HKSAR Government has been actively developing the intermodal transport networks through various means so as to enhance the convenience for the transport of passengers and goods in the GBA to and from all parts of the world via Hong Kong. Among these, the Airport Authority Hong Kong and the Zhuhai Municipal Government signed a memorandum of understanding to deepen the co-operation between Hong Kong International Airport and Zhuhai Airport. In this regard, the "Fly-Via-Zhuhai-HK" direct passenger service was launched in December 2023, so that Mainland and international passengers can enjoy seamless travel between the Mainland and other places in the world via Zhuhai and Hong Kong in an "air-land-air" mode using the HZMB. We look forward to the early implementation of other relevant co-operation in order to achieve greater synergy between the two airports.

The National 14th Five-Year Plan clearly supports Hong Kong in enhancing its role as the international trade centre and developing into a regional intellectual property trading centre. The HKSAR Government will seize the enormous opportunities brought about by the national strategy and continue to strengthen the co-operation between Guangdong and Hong Kong, with a view to bringing the economic and trade co-operation of the two places to a higher level.

Through the promulgation of annual co-operation plans under the Guangdong/Hong Kong Expert Group on the Protection of Intellectual Property Rights (Expert Group), the Intellectual Property Department of the HKSAR Government continues to co-operate with relevant intellectual property (IP) departments in the Mainland and Macao in areas such as strengthening IP protection and nurturing IP professionals and talents in the GBA. Since 2003, Guangdong and Hong Kong have completed more than 270 co-operation projects. The Expert Group has finalised a two-year co-operation plan for 2024 and 2025, focusing on developing a world-class Bay Area, supporting the high-quality development of the manufacturing sector through strengthening and

offering eligible Hong Kong elderly persons additional options of services points for using the Elderly Health Care Vouchers (EHCVs) in the GBA. Among the medical institutions included in the Pilot Scheme, five of them provide integrated services (including dental services) which are located in Guangzhou, Nansha, Zhongshan, Dongguan and Shenzhen, while the other two are dental institutions located in Shenzhen, enabling eligible Hong Kong elderly persons to use EHCVs to pay for services received. It is estimated that some 1.7 million eligible Hong Kong elderly persons will benefit from the Pilot Scheme. The coverage of EHCVs extended to include the First Affiliated Hospital, Sun Yat-sen University (FAH-SYSU) in Guangzhou from June 28, offering another service point where eligible Hong Kong elderly persons can use EHCVs for outpatient healthcare services in the GBA. Starting from July 18, the coverage of EHCVs will be further extended to include ZhongshanChenxinghai Hospital of Integrated Traditional Chinese and Western Medicine in Zhongshan. The remaining pilot medical institutions will launch the relevant arrangements from the third quarter of this year.

As regards health and medical innovation, the HKSAR Government will establish the Greater Bay Area International Clinical Trial Institute (GBAICTI) in the Hetao area by the end of 2024. The GBAICTI will provide one-stop clinical trial support services to further enhance the capacity and efficiency of clinical trials in Hong Kong. The HKSAR Government is actively discussing with the Shenzhen Municipal Government to jointly establish a clinical trial collaboration platform in the Hong Kong Park and Shenzhen Park of the Hetao Shenzhen-Hong Kong Science and Technology Innovation Co-operation Zone under the "one zone, two parks" model for the co-ordinated development of clinical trials, with a view to establishing a GBA clinical trial network leveraging a population base of over 86 million for conducting cross-boundary multi-centre clinical trials, and developing the HKSAR into an international health and medical innovation hub in the long run.

Regarding cross-boundary ambulance arrangement, the HKSAR Government is finalising the implementation details of the "Pilot Scheme for Direct Cross-Boundary Ambulance Transfer in the GBA" with the governments of Guangdong and Shenzhen, to enable direct point-to-point transfer of patients with special medical needs from The Hong Kong University-Shenzhen Hospital to public hospitals in Hong Kong without the need to change ambulances at control points.

As regards the development of Chinese medicine (CM), the HKSAR Government has been actively promoting the construction of the GBA CM highlands, and has taken forward work on various fronts, including the signing of strategic collaboration agreement between the Guangdong Provincial Hospital of Traditional Chinese Medicine and the Chinese Medicine Hospital of Hong Kong to establish a close partnership between the two hospitals and support the continuing development of the Chinese Medicine Hospital of Hong Kong; the roll-out of programmes such as the "GBA CM Visiting Scholars Programme" and "CM Enhanced In-patient Training Programme with GBA" by the Hospital Authority to foster talent exchange and nurturing; the recruitment of Hong Kong CM practitioners by public healthcare institutions in the GBA; and the registration and sale of Hong Kong-registered traditional proprietary

for Commerce and Economic Development, Dr Bernard Chan; and the Acting Secretary for Environment and Ecology, Miss Diane Wong.

Deputy Director of the Liaison Office of the Central People's Government in the HKSAR, Mr Yin Zonghua, and Member of the Office Leadership of the Hong Kong and Macao Work Office of the Communist Party of China Central Committee and the Hong Kong and Macao Affairs Office of the State Council, Mr Xiang Bin, also attended the meeting as special guests.



Frozen confection sample detected with coliform bacteria and total bacterial counts exceeding legal limit

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department announced today (July 12) that a sample of frozen confection was found to contain coliform bacteria and total bacterial counts exceeding the legal limit. The CFS is following up on the incident.

A spokesman for the CFS said, "The CFS collected the above-mentioned sample from a restaurant in Repulse Bay for testing when following up on a related food incident. The test result showed that the sample contained 410 coliform bacteria per gram and 160 000 bacteria per gram, exceeding the legal limit."

"The CFS has informed the restaurant concerned of the irregularity. The restaurant has already stopped selling and discarded the affected product according to the CFS's advice. The CFS has also provided health education on food safety and hygiene to the person-in-charge and staff of the restaurant, and requested it to carry out thorough cleaning and disinfection. Prosecution will be instituted should there be sufficient evidence," the spokesman said.

Under the Frozen Confections Regulation (Cap. 132AC), frozen confection for sale should not contain more than 100 coliform bacteria per gram or more than 50 000 bacteria per gram. The maximum penalty for offenders is a fine of \$10,000 and three months' imprisonment upon conviction. The fact that the coliform count and the total bacterial count exceeded the legal limit indicated that the hygienic conditions were unsatisfactory, but did not mean that consumption would lead to food poisoning.

The CFS will continue to follow up on the incident and take appropriate action to safeguard food safety and public health.
