

# HKMA alerts public to frauds purportedly associated with Wealth Management Connect Scheme

The following is issued on behalf of the Hong Kong Monetary Authority:

The Hong Kong Monetary Authority (HKMA) has received public enquiries recently on suspected frauds associated with the Cross-boundary Wealth Management Connect Scheme (Scheme):

1. Victims incurring investment losses were approached by fraudsters who claimed that the Government could intervene to recoup their losses but only if they open so-called accounts under the Northbound Scheme and pay a fee; and
2. A bogus advertisement was disseminated on social media about a time deposit product with high interest rate purportedly offered by the HKMA. The fraudster then posed as an account manager and tried to lure members of the public into depositing money into a so-called account under the Northbound Scheme.

We want to reiterate that the HKMA will not contact individual members of the public regarding personal financial matters. We also wish to alert the public that only eligible institutions can provide services under the Scheme. If in doubt, members of the public are advised to carefully fact check. # LegCo delegation to conduct duty visit to Malaysia, Indonesia and Singapore

The following is issued on behalf of the Legislative Council Secretariat:

The President of the Legislative Council (LegCo), Mr Andrew Leung, will lead seven members of the Parliamentary Liaison Subcommittee (the Subcommittee) to conduct a seven-day duty visit to Malaysia, Indonesia and Singapore on Sunday (May 12).

Malaysia, Indonesia and Singapore, being members of the Association of Southeast Asian Nations (ASEAN), are very important trading partners of Hong Kong. Apart from meeting with local Speakers and Members of Parliaments, the LegCo delegation will also take the opportunity to exchange views with the relevant government departments and organisations. The objectives are to strengthen liaison with them and gain a better understanding of the latest development of these countries in respect of their political systems, economic and tourism development, innovation and technology, nurturing of emerging industries, etc.

During the visit from May 12 to 18, the delegation will meet and exchange views with the Chinese Ambassadors to ASEAN, representatives of other ASEAN countries, Chinese Ambassadors to Malaysia, Indonesia and Singapore, and local Hong Kong businessmen and communities.

## **Cluster of Influenza A cases at Castle Peak Hospital**

The following is issued on behalf of the Hospital Authority:

The spokesperson for Castle Peak Hospital made the following announcement today (May 10):

Three patients (aged 31 to 69) in a male adult psychiatric ward have presented with respiratory symptoms since May 6. Appropriate viral tests have been arranged for the patients and their test results were positive for Influenza A. The patients concerned are being treated in isolation and are in stable condition.

Admission to the ward has been suspended and restricted visiting has been imposed. Infection control measures have already been stepped up according to established guidelines. All other patients in the ward are under close surveillance.

The cases have been reported to the Hospital Authority Head Office and the Centre for Health Protection for necessary follow-up.

The Hong Kong Pop Culture Festival 2024, organised by the Leisure and Cultural Services Department (LCSD), will present "Fame in a Flash – A Tour of AVON Recording Studios" in June. Through the guided tour, participants will be able to unveil the mystery of this legendary studio and experience the thrill of being a singer, with the help of professional audio mixers and high-quality sound equipment. Tickets will be on sale from May 14 (Tuesday).

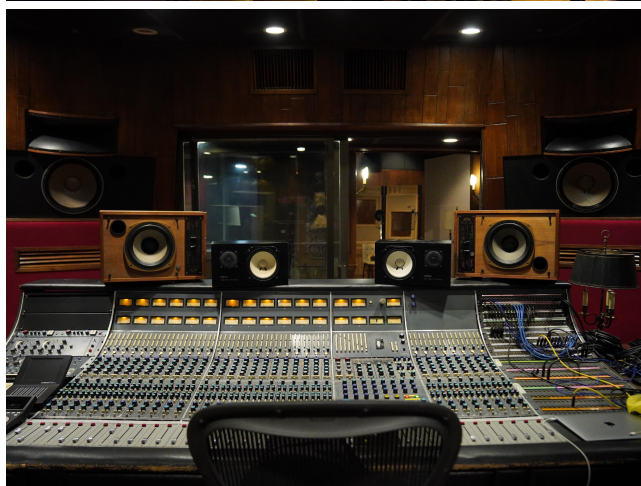
Founded in 1983, the Avon Recording Studios is one of the most esteemed professional recording facilities in Hong Kong, bearing witness to the birth of countless classic pop songs. Luminaries of the music scene, such as Danny Chan, Leslie Cheung, Anita Mui, and Roman Tam, as well as 1990s superstars like Aaron Kwok, Leon Lai, Sandy Lam, and Faye Wong, have graced the studio. In the new millennium, Cantopop icons like Joey Yung and Eason Chan, along with recent popular idols Ian Chan and Keung To, have also recorded their music in this studio.

This "Pop Music Hall of Fame" is a repository of many precious materials relating to Hong Kong's pop culture. With its highly practical acoustic design, the studio boasts a \$1 million mixing console, premium-quality microphones, and antique audio equipment sourced from around the world. Its nostalgic decor is also unique to itself in many ways. During the guided tour, which lasts approximately 75 minutes, participants will not only learn about the design details and captivating stories of the recording studio, but will also have the opportunity to take memorable photos in different spots. In addition, each participant will have the chance to take part in a "demo recording" session, where they can choose a song from a special playlist featuring around a dozen titles from different eras, and record a one-minute segment of their singing like a superstar. At the end of the event, each participant will receive a personalised audio record as memento so that they may recall this music journey anytime they like.

"Fame in a Flash – A Tour of AVON Recording Studios" has altogether 16 sessions – four sessions each on June 8, 15, 22 and 29 (four consecutive Saturdays). Tickets are priced at \$180; a maximum of two tickets can be purchased in each transaction, and persons below 12 will not be admitted. Tickets will go on sale on May 14 at the URBTIX website ([www.urbtix.hk](http://www.urbtix.hk)) and its mobile ticketing app URBTIX (Android, HarmonyOS and iPhone/iPad versions). Tickets can be booked through the Internet and mobile app, but not at the URBTIX counter, telephone nor self-service ticketing kiosk. ## [Annual reciprocal visit between HKSARG and MFA to take place next week](#)

The Constitutional and Mainland Affairs Bureau will lead a delegation of the Hong Kong Special Administrative Region (HKSAR) Government to visit Beijing and Guizhou from May 12 to 17 under the annual reciprocal visit arrangement between the HKSAR Government and the Ministry of Foreign Affairs (MFA). The visit arrangement has been in place since 1999 to enhance communication and exchange between the two sides. It had been suspended during 2020-22 due to the COVID-19 epidemic, and was relaunched last year.

The Secretary for Constitutional and Mainland Affairs, Mr Erick Tsang Kwok-wai, will lead the HKSAR Government delegation to visit Beijing from May

12 to 15, and the Permanent Secretary for Constitutional and Mainland Affairs, Ms Gracie Foo, will lead the HKSAR Government delegation to visit Guizhou from May 15 to 17.

While in Beijing, the delegation will meet with officials of the MFA and other central ministries from May 12 to 15. The delegation will then visit Guizhou from May 15 to 17, where it will meet with officials of Guizhou and study developments in various areas of the province.

Mr Tsang will return to Hong Kong in the afternoon on May 15. During his absence, the Under Secretary for Constitutional and Mainland Affairs, Mr Clement Woo, will be the Acting Secretary for Constitutional and Mainland Affairs.
