On September 27, Deputy Secretary of State John J. Sullivan met with the Foreign Ministers and other senior representatives from Fiji, the Federated States of Micronesia, Nauru, Papua New Guinea, Marshall Islands, Samoa, and Tonga, as well as representatives from the Pacific Islands Forum Secretariat, and the Pacific Community, on the sidelines of the United Nations General Assembly.

Secretary of State Michael R. Pompeo met September 27 with Burmese Minister for the Office of the State Counsellor Kyaw Tint Swe in New York on the

margins of the UN General Assembly meetings. While underscoring U.S. support for the democratic transition in Burma and efforts to achieve national peace and reconciliation, the Secretary urged the Government of Burma to take concrete steps to investigate the human rights abuses chronicled by the U.S. Documentation Report and UN Fact Finding Mission and to hold accountable members of the security forces and others responsible for these acts. The Secretary also called for the Burmese government to immediately release jailed Reuters reporters Wa Lone and Kyaw Soe Oo and to strengthen and protect freedom of expression and the press.
