CHP investigates 1 625 confirmed and 1 253 asymptomatic additional SARS-CoV-2 virus cases with 2 854 cases pending status by nucleic acid tests as well as 7 342 cases tested positive by rapid antigen tests (with photo)

The Centre for Health Protection (CHP) of the Department of Health (DH) today (March 24) announced the latest epidemic situation of COVID-19. As of 0.00am, March 24, the CHP was investigating 5 732 additional cases that tested positive for the SARS-CoV-2 virus by nucleic acid tests (1 625 confirmed cases, 1 253 asymptomatic cases and 2 854 cases with pending case status) in the past 24 hours. Separately, 7 342 additional positive cases through rapid antigen tests (RAT) (4 664 symptomatic cases and 2 678 asymptomatic cases) were reported. Hong Kong has recorded a total of 710 884 and 390 340 cases that tested positive by nucleic acid tests and RAT respectively for the SARS-CoV-2 virus so far.

The aforementioned newly reported cases consist of one imported case and 5 731 locally acquired cases tested positive by nucleic acid tests, as well as 7 342 locally acquired cases tested positive by RAT. The CHP is continuing with epidemiological investigations on the cases. In addition, as of 0.00am, March 24, a total of 6 557 deaths that have been tested positive for the SARS-CoV-2 virus during the fifth wave (since December 31, 2021) was recorded, with 6 515 and 42 deaths reported from the Hospital Authority and public mortuaries respectively. Hong Kong has so far recorded a total of 6 770 deaths that have been tested positive for the SARS-CoV-2 virus.

Furthermore, among the earlier cases by nucleic acid tests reported, there were cases (including pending cases) changed to confirmed, asymptomatic or re-positive cases. As at yesterday (March 23), the total number of confirmed cases was 280 384, while the figures for asymptomatic cases, re-positive cases, pending/unknown cases recorded since January 1 were 142 451, 10 and 282 307 respectively.

The spokesman for the CHP stressed that the local situation of COVID-19 infection became severe recently and there is a continuous increase in the number of cases involving mutant strains that carry higher transmissibility. With the higher transmissibility and risk of infection of the Omicron mutant strain, the CHP strongly appeals to the community to continue to comply with the social distancing measures, avoid going out and refrain from

participating in unnecessary or crowded activities or gatherings (particularly religious or cross-family activities and gatherings). This would lower the risk of infection and prevent the virus from spreading in the community.

â€<The spokesman reminded that COVID-19 vaccines are highly effective in preventing severe cases and deaths from the SARS-CoV-2 virus. They can provide effective protection to those vaccinated in preventing serious complications and even death after infection. People who are yet to receive vaccination, especially senior citizens, chronic patients and other immunocompromised persons who face a higher chance of death after COVID-19 infection, should get vaccinated as early as possible for self-protection and to reduce the risk of falling seriously ill and death should they get infected. Meanwhile, a person who gets COVID-19 and influenza at the same time may be more seriously ill and would have a higher risk of death. Influenza vaccination may reduce the likelihood of hospitalisation and the length of stay. In addition, seasonal influenza vaccination is recommended for all persons aged 6 months or above except those with known contraindications. Persons at higher risk of getting influenza and its complications, including the elderly and children, should receive seasonal influenza vaccination early.
