

CHP investigates one additional confirmed case of COVID-19 and updates on its investigations into case 11952

The Centre for Health Protection (CHP) of the Department of Health (DH) announced that as of 0.00am, July 13, the CHP was investigating one additional confirmed case of coronavirus disease 2019 (COVID-19), taking the number of cases to 11 953 in Hong Kong so far (comprising 11 952 confirmed cases and one probable case).

The newly reported case is an imported case.

A total of 31 cases have been reported in the past 14 days (June 29 to July 12), including one local case with unknown sources, 29 imported cases and one import-related case.

The CHP has been actively conducting epidemiological investigations into case 11952 involving the L452R mutant strain. The affected person worked as a porter at the Hong Kong International Airport (HKIA) and mainly performed duties at the apron. The genetic sequencing completed by the Public Health Laboratory Services Branch of the DH revealed that this case involved the Delta mutant strain and was found to be different from case 11902, an airline ground crew staff member at HKIA involving the Delta mutant strain. The genetic analysis of case 11952 is found to be related to genomes of four imported cases from Russia, including case 11947 (an aircrew member of cargo flight RL9933 on which case 11952 had served), case 11887 (cargo flight crew from Russia on June 19), 11926 and 11938 (a couple from Russia arriving in Hong Kong on June 29).

According to CHP's latest epidemiological investigation, among the flights that case 11952 had served during the incubation period, there was one confirmed case 11947 affecting an aircrew member of flight RL9933 arriving from Moscow on July 6. While case 11952 had no direct contact with case 11947, he had stayed and worked in the cabin for several hours of this flight where some turn-around aircrew members had stayed in the plane all along. Case 11952 might have been infected from some undiagnosed cabin crew in this flight from Russia. The CHP is following up the case with the overseas health authority and further investigation is still ongoing.

The CHP's epidemiological investigations and relevant contact tracing on the confirmed cases are ongoing. Meanwhile, the CHP reminded those who had visited specified venues under the Prevention and Control of Disease (Compulsory Testing for Certain

Persons) Regulation (Cap. 599J) to receive COVID-19 nucleic acid testing according to compulsory testing notices (CTNs). The Regulation also requires all household members of close contacts of confirmed cases to undergo a COVID-19 nucleic acid test within a specified period according to CTNs published in the Gazette. The public are also urged to seek medical attention early if symptoms develop, and undergo testing as soon as possible.

The Government has launched the COVID-19 Vaccination Programme. Members of the public are encouraged to get vaccinated. Details of the programme can be found at the designated website (www.covidvaccine.gov.hk).

The CHP called on members of the public to avoid going out, having social contact and dining out. They should put on a surgical mask and maintain stringent hand hygiene when they need to go out. The CHP strongly urged the elderly to stay home as far as possible and avoid going out. They should consider asking their family and friends to help with everyday tasks such as shopping for basic necessities.

The spokesman said, "Given that the situation of COVID-19 infection remains severe and that there is a continuous increase in the number of cases including mutant strains reported around the world, members of the public are strongly urged to avoid all non-essential travel outside Hong Kong.

"The CHP also strongly urges the public to maintain at all times strict personal and environmental hygiene, which is key to personal protection against infection and prevention of the spread of the disease in the community. On a personal level, members of the public should wear a surgical mask when having respiratory symptoms, taking public transport or staying in crowded places. They should also perform hand hygiene frequently, especially before touching the mouth, nose or eyes. Moreover, vaccination may help keep people from getting seriously ill even if they do get COVID-19, and, generally speaking, vaccines can also reduce the chance of transmission by those who have been vaccinated. People vaccinated with a COVID-19 vaccine can also generate herd immunity. Members of the public are urged to get vaccinated as soon as possible and book their vaccination appointments at the website (booking.covidvaccine.gov.hk/forms/index.jsp).

"As for household environmental hygiene, members of the public are advised to maintain drainage pipes properly and regularly pour water into drain outlets (U-traps). After using the toilet, they should put the toilet lid down before flushing to avoid spreading germs."

Moreover, the Government has launched the website "COVID-19 Thematic Website" (www.coronavirus.gov.hk) for announcing the latest updates on various news on COVID-19 infection and health advice to help the public understand the latest updates. To prevent pneumonia and respiratory tract infections, members of the public should always maintain good personal and environmental hygiene. They are advised to:

- Wear a surgical mask when taking public transport or staying in crowded places. It is important to wear a mask properly, including performing hand hygiene before wearing and after removing a mask;
- Perform hand hygiene frequently, especially before touching the mouth, nose or eyes, after touching public installations such as handrails or doorknobs, or when hands are contaminated by respiratory secretions after coughing or sneezing;
- Maintain drainage pipes properly and regularly (about once a week) pour about half a litre of water into each drain outlet (U-trap) to ensure environmental hygiene;
- After using the toilet, put the toilet lid down before flushing to avoid spreading germs;
- Wash hands with liquid soap and water, and rub for at least 20 seconds. Then rinse with water and dry with a disposable paper towel. If hand washing facilities are not available, or when hands are not visibly soiled, performing hand hygiene with 70 to 80 per cent alcohol-based handrub is an effective alternative;
- Cover your mouth and nose with tissue paper when sneezing or coughing. Dispose of soiled tissues into a lidded rubbish bin, then wash hands thoroughly; and
- When having respiratory symptoms, wear a surgical mask, refrain from work or attending class at school, avoid going to crowded places and seek medical advice promptly.
