These standard rules allow you to operate a household, commercial and industrial waste transfer station and asbestos storage, provided that the permitted activities are not carried out within:

- 200 metres of a European Site, Ramsar site or Site of Special Scientific Interest
- 50 metres of any well, spring or borehole used for the supply of water for human consumption, including private water supplies

<u>Statutory guidance: SR2015 No 18:</u> <u>metal recycling, vehicle storage,</u> <u>depollution and dismantling facility</u>

Updated: Added to 'details' section: You can apply online for most standard rules environmental permits.

These standard rules allow you to operate a metal recycling site and a vehicle depollution and dismantling facility at a specified location.

These rules will permit the sorting, separation, grading, shearing, baling, compacting, granulating of cables and cutting using hand-held equipment only, of ferrous metals or alloys and non-ferrous metals for recovery as well as the recovery (including storage) of all waste motor vehicles.

The total quantity of waste that can be accepted at a site under these rules must be less than:

- 25,000 tonnes a year of waste metal
- 5,000 tonnes a year of waste motor vehicles

The rules will not permit the burning of any wastes, either in the open, inside buildings or in any form of incinerator.

<u>Statutory guidance: SR2015 No 6: 75kte</u> <u>household, commercial and industrial</u> <u>waste transfer station with treatment</u>

These standard rules allow you to operate a household, commercial and industrial waste transfer station with waste treatment at a specified location.

The permitted activities must not be carried out within:

- 500 metres of a European Site, Ramsar site or Site of Special Scientific Interest
- 50 metres of any well, spring or borehole used for the supply of water for human consumption, including private water supplies

Specified waste cannot be treated outside a building within a specified air quality management area.

household, commercial and industrial waste transfer station (no building)

These standard rules allow you to operate a household, commercial and industrial waste transfer station at a specified location, provided that the permitted activities are not carried out within:

- 200 metres of a European Site, Ramsar site or Site of Special Scientific Interest
- 50 metres of any well, spring or borehole used for the supply of water for human consumption, including private water supplies
- 200 metres of any residential dwelling or workplace

<u>Statutory guidance: SR2015 No 15:</u> <u>75kte WEEE authorised treatment</u> <u>facility excluding ozone depleting</u> <u>substances</u>

Updated: Added to 'details' section: You can apply online for most standard rules environmental permits.

These standard rules allow you to operate a waste electrical and electronic equipment (WEEE) authorised treatment facility at a specified location. The total quantity of waste that can be accepted at a site under these rules must be less than 75,000 tonnes a year.

The rules will not permit the treatment of WEEE containing ozone depleting substances — they can be accepted for storage only.
