

# Government finishes exercise on “restriction-testing declaration” in respect of specified “restricted area” in Sha Tin and enforcement operation for breaches of compulsory testing notice (with photo)

The Government exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" on February 19 with effective from 6pm, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Sha Tin (i.e. Pok Tat House, Pok Hong Estate, Sha Tin, excluding Tsung Tsin Mission of Hong Kong Sha Tin Integrated Services Centre, Tsung Tsin Mission of Hong Kong Pok Hong Children And Youth Centre, Pentecostal Holiness Church Ling Hong Assembly Limited and Pentecostal Holiness Church Ling Hong Assembly Limited Pok Hong Study Centre on G/F) were required to stay in their premises and undergo compulsory testing. The Government yesterday (February 20) extended the period of operation to today (February 21). Persons subject to compulsory testing were required to stay in their premises and undergo two tests under the designated arrangement until all such persons identified in the "restricted area" had undergone testing and the test results were mostly ascertained.

In addition, the Government issued a compulsory testing notice on February 19, requiring persons who had been present at the above building for more than two hours from February 6 to February 19, 2022, even if they were not present in the "restricted area" at the time when the declaration took effect, to undergo compulsory testing on or before February 21, 2022. The Government announced the completion of the compulsory testing exercise at around 2pm today and carried out enforcement action in the "restricted area" afterwards to verify that all people in the "restricted area" had undergone compulsory testing in accordance with the requirements of the relevant declaration and compulsory testing notice. The Government announced that the enforcement operation ended at around 3.30pm today.

In this exercise, the Environment Bureau, the Environmental Protection Department, the Hong Kong Police Force, the Food and Environmental Hygiene Department and the Tobacco and Alcohol Control Office of the Department of Health mobilised around 470 staff to arrange for implementation of the declaration and enforcement actions for breaches of the compulsory testing notice issued earlier.

The Government thanks persons subject to compulsory testing for their support and understanding. With everyone's co-operation and efforts, coupled

with the tireless efforts of the testing contractors, residents have been informed about their testing results by SMS notification. After finishing the compulsory testing exercise at around 2pm today, the Government took enforcement action in the "restricted area" immediately to verify that all people in the "restricted area" had undergone testing according to the requirements of the declaration and the compulsory testing notice. Persons who could present an SMS notification containing a negative testing result or wore a wristband as proof of having undergone the compulsory testing could leave the "restricted area" through the designated exit after providing personal information to a prescribed officer. The enforcement operation was completed at around 3.30pm. Test records of 764 persons subject to compulsory testing were checked. Nobody was found to have not undergone compulsory testing. Taking into account the above situation, the Secretary for Food and Health revoked the "restriction-testing declaration" in accordance with Cap. 599J (see attachment).

The Government reminds the 14 households who have not answered the door to contact the Government for arrangement of testing as soon as possible after reading the notices put up by the Government, in the hope of eliminating the possible risk of further spread of the virus in the community.

The Government thanks all participating government staff and the testing agencies for their hard work. The Government is also grateful to those subject to compulsory testing for their support and understanding, and their full co-operation during this period in undergoing testing and waiting for the results at home.

The Government will seriously follow up on the compliance situation of the compulsory testing notices and the "restriction-testing declaration" by persons subject to compulsory testing. Any person who fails to comply with the compulsory testing notices commits an offence and may be liable to a fixed penalty of \$10,000. The person will also be issued with a compulsory testing order, requiring him or her to undergo testing within a specified time frame. Failure to comply with the order or the "restriction-testing declaration" is an offence and the offender may be liable to a fine of level 4 (\$25,000) and imprisonment for six months.
