

## **HAD distributes complimentary COVID-19 rapid test kits to households, cleansing workers and property management staff in Yuen Long, Kowloon City, Tai Po and Kwai Tsing (with photos)**

In light of positive test results for the COVID-19 virus from some sewage samples collected in Yuen Long, Kowloon City, Tai Po and Kwai Tsing, the Home Affairs Department (HAD) said today (April 23) that the Yuen Long District Office (YLD0), the Kowloon City District Office (KCD0), the Tai Po District Office (TPD0) and the Kwai Tsing District Office (K&TD0) have distributed a total of about 130 000 COVID-19 rapid test kits (rapid test kits) to households, cleansing workers and property management staff living and working in the districts.

The YLD0 distributed rapid test kits to households, cleansing workers and property management staff living and working in residential premises around Castle Peak Road Hung Shui Kiu through the property management companies, the owners' corporations and the Village Representatives.

The KCD0 and the TPD0 also distributed rapid test kits to households, cleansing workers and property management staff living and working in Lok Man Sun Chuen in Kowloon City District and Eightland Gardens, Ting Nga Court, Treasure Garden and Jade Plaza in Tai Po District for voluntary testing through the property management companies.

In addition, the K&TD0 distributed rapid test kits to households, cleansing workers and property management staff living and working in Kau Wa Keng San Tsuen, Kau Wah Keng Old Village, Greenwood Regency, Phase 1 to 3 of Greenwood Villas, Happy Villa, Chung Shan Lodge, Regency Park and Wonderland Villas through the Village Representatives and the property management companies.

The HAD made the above arrangements in the hope of identifying infected persons early.

Persons tested positive through an RAT should take a photo of the test result and declare the result within 24 hours via the Declaration System for

Individuals Tested Positive for COVID-19 Using Rapid Antigen Test ([www.chp.gov.hk/ratp](http://www.chp.gov.hk/ratp)). If members of the public encounter difficulties in using the online platform, they can call the automated system at 183 6119 to register their identification document and telephone number. The CHP under the DH will contact the relevant person later to complete the report procedure. There is no need to declare negative test results.

The Government appeals for the co-operation of members of the public to safeguard the health of themselves and their families by undergoing testing on a voluntary basis and fighting the virus together. The Government urges all individuals who are in doubt about their own health condition, or individuals with infection risks (such as individuals who visited places with epidemic outbreaks or had contact with cases that tested positive), to undergo testing promptly for early identification of infected persons to reduce the transmission risks of COVID-19.
