## Land Registry staff member preliminarily tested positive for COVID-19 and temporary service arrangements

The Land Registry (LR) today (February 10) said that a staff member was preliminarily tested positive for COVID-19.

The staff member works in the Customer Centre of LR on 19/F, Queensway Government Offices and is responsible for delivering owners' corporation services. She has no recent travel history and last worked in office on February 4. Her body temperature was normal on the last day of work and she has been wearing a mask and following infection control measures at work.

Thorough cleaning and disinfection will be arranged at the premises concerned as soon as possible. The LR will also arrange staff of the same floor to undergo COVID-19 testing and work from home until a negative test result is obtained. The LR will maintain close liaison with the Centre for Health Protection of the Department of Health in taking appropriate follow-up action.

The Customer Centre on 19/F, Queensway Government Offices will be closed today and resume services tomorrow (February 11). Today's temporary service arrangements are as follows:
