â€< All persons are required to use the "LeaveHomeSafe" mobile application to scan the venue QR code before they are allowed to enter LCSD offices and venues, except for exempted persons who are aged below 12 or aged 65 or above and those with disabilities that render use of the app difficult. Exemptions will also be granted to individual persons depending on the actual circumstances. All exempted persons are required to complete a record form to register their personal particulars and the date and time of their visit.
