

New membership of Trade and Industry Advisory Board announced

The Government announced today (December 27) new membership of the Trade and Industry Advisory Board (TIAB) for a period of two years from January 1, 2020, to December 31, 2021.

The new members are Mr Ivan Chu Kwok-leung, Dr Dennis Ng Wang-pun, Mr Sunny Tan, Mr Harold Wong Tsu-hing and Dr Daniel Yip Chung-yin, and 24 incumbent members are re-appointed.

The Secretary for Commerce and Economic Development, Mr Edward Yau, thanked the members for accepting the appointments.
