Public consultation exercise launched for mid-term review of domestic free television programme service licences and sound broadcasting licences

The following is issued on behalf of the Communications Authority:

The Communications Authority (CA) announced today (September 10) the commencement of the public consultation exercise for the mid-term review of the domestic free television programme service (free TV) licences of Fantastic Television Limited (Fantastic TV), HK Television Entertainment Company Limited (HKTVE) and Television Broadcasts Limited (TVB), and the sound broadcasting licences of Hong Kong Commercial Broadcasting Company Limited (CRHK) and Metro Broadcast Corporation Limited (Metro). The CA invites members of the public to give their views on the services of Fantastic TV, HKTVE, TVB, CRHK and Metro for assessment of their performance.

The free TV licences of HKTVE, TVB and Fantastic TV are valid for 12 years from April 1, 2015, to March 31, 2027, from December 1, 2015, to November 30, 2027, and from May 31, 2016, to May 30, 2028, respectively. The sound broadcasting licences of CRHK and Metro are valid for 12 years from August 26, 2016, to August 25, 2028. Pursuant to the relevant statutory requirements and licence conditions, these licences shall be subject to review by the Chief Executive in Council in the sixth year of the 12-year validity period of the licence between 2021 and 2022. Given the proximity of the review periods of these licences and to more efficiently manage these mid-term reviews, the CA decided to conduct a consolidated exercise for all the free TV and sound broadcasting licences. Following the established practice, the CA will evaluate the licensees' performance against the various statutory requirements and licence conditions as well as formulate recommendations for consideration and approval by the Chief Executive in Council. The CA will take into account public views received in making recommendations to the Chief Executive in Council.

The consultation period will last for two months until November 9, 2021. In tandem, the CA has commissioned an independent survey company (see Note) to conduct an opinion survey to collect public views on the services provided by the three domestic free TV licensees and the two sound broadcasting licensees. An online public consultation (OPC) session will also be conducted by the CA on September 25, 2021, to listen to views and suggestions expressed by members of the public on the licensees' services. Note: The CA has commissioned the Nielsen Company (Hong Kong) Limited to conduct the opinion survey. The fieldwork is expected to be conducted between October and December 2021.
