

# Press release: British public urged to be aware of poppy merchandise scams

- the Intellectual Property Office and The Royal British Legion urge consumers to beware of fake poppy merchandise ahead of Remembrance 2018
- no-one benefits – both charity and public lose out with fake poppy merchandise
- advice to buyers to 'buy responsibly' through official channels, and how to report fake poppy merchandise

The Intellectual Property Office (IPO) and The Royal British Legion (RBL) are urging members of the British public to be extra vigilant when buying poppy merchandise for Remembrance this year. Their donations are intended to support Armed Forces community men, women, veterans and their families. Instead they could end up benefitting fraudsters if their poppy merchandise turns out to be fake.

The RBL has registered its rights for the poppy goods to prevent such counterfeiting.

The IPO and The RBL have teamed up with the Police Intellectual Property Crime Unit (PIPCU) to crack down on the rogue traders making money from the fake Remembrance goods. The warning applies to poppy merchandise – scarves, jewellery, poppy pins and larger poppy brooches. This does NOT apply to the traditional paper poppies.

The PIPCU team has been targeting suspected sellers by visiting addresses and speaking with people in connection with this crime. In Autumn 2017, Border Force officers at Tilbury intercepted a shipment of poppy merchandise intended for the UK worth in the region of £150,000.

Intellectual Property Minister Sam Gyimah said:

It is truly shocking that anyone would target and exploit one of the UK's most cherished charities and take advantage of public support for our Armed Forces community

Together we can ensure donations go to the people they are intended for, by only supporting approved merchandise. Be vigilant when you are buying your poppies this year, and look out for the Royal British Legion logo to ensure the merchandise is approved and genuine.

Claire Rowcliffe, Director of Fundraising, from The Royal British Legion said:

It is a sad fact that there are people who actively defraud the

public in order to take funds intended for the support of our Armed Forces community. We would urge everyone wishing to purchase a Remembrance poppy brooch, to do so through official channels. For example, you can buy from one of our trusted volunteers, from The Royal British Legion's online Poppy Shop, or from one of our corporate partners.

Join with us, the IPO and PIPCU to help make sure your donation doesn't line the pockets of criminals. We want to make sure that it goes to supporting those who have made such a unique contribution to our society.

## **Fake poppy merchandise – what to look for**

The public are being asked to look out for counterfeit goods in the shape, or bearing the image of, the RBL's familiar two-petal red poppy, or Poppy Scotland's four-petal poppy in Scotland. The RBL have registered their rights for the poppy goods to prevent such counterfeiting.

To help consumers beat the fraudsters, here are the top tips to avoid buying fake poppy merchandise online:

- be a 'responsible buyer' – buy from official channels and The Royal British Legion's corporate partners
- avoid cheaper priced products. If the price is too good to be true, it usually is
- the Royal British Legion works with a number of corporate partners. Only [corporate partners](#) are authorised by the Royal British Legion to sell poppy merchandise
- if in doubt, buy through [The Royal British Legion](#) or [The Royal British Legion official eBay](#) or Amazon pages – you will be sure of the authenticity

## **Press release: Strengthening prisoners' family ties: the 'golden thread' to reducing reoffending**

Strengthening family ties can play a crucial role in helping offenders to turn their lives around beyond the prison gates, Welsh Secretary Alun Cairns said today following a visit to HM Prison and YOI Parc in Bridgend.

The visit to HMP Parc – which is the only privately-run prison in Wales – comes in the year following the publication of a UK Government-commissioned report, which identified family relationships as the “golden thread” running through the reforms across the prison estate.

Mr Cairns met with Parc prison director, Janet Wallsgrove and prison staff to see first-hand how incorporating family members into the prison's innovative rehabilitation schemes is having a significant impact on preventing prisoners from reoffending after release.

In September 2016, [Lord Michael Farmer](#), in partnership with the membership charity Clinks, was commissioned by the UK Government to investigate how connecting prisoners with their families can improve offender wellbeing, assist in keeping the public safe and reduce reoffending.

During the visit to HMP Parc, the Secretary of State met Corin Morgan-Armstrong, head of family interventions for G4S Central Government Services in the UK, who highlighted how the success of the prison's 'Invisible Walls Wales' project has helped to inform the Farmer Review, and outlined the tangible results the scheme is having on the rehabilitation of offenders.

### **Secretary of State for Wales, Alun Cairns said:**

Safe and secure prison environments are just the foundation for successful rehabilitation. But as Lord Farmer's review outlined last year, building and nurturing family relationships is also fundamentally important if people are to change.

It has been inspiring to meet the passionate staff at HMP Parc and to experience how they are pursuing trailblazing initiatives like 'Invisible Walls Wales'. It's also been an experience to listen to prisoners who have taken up the opportunities available, using their own drive and determination to change as they look towards life beyond the prison gates.

Backed by Big Lottery Fund investment and working in partnership with Barnardo's Cymru, the Invisible Walls Wales scheme helps prisoners to strengthen family ties and maintain healthy family relationships as well as providing them with advice on issues such as debt, housing, training and moving towards employment.

**Janet Wallsgrove, Director of HMP & YOI Parc said:**

Initiatives such as Invisible Walls Wales, and the wide range of educational and training programmes which are offered at HMP Parc, all play a key part in supporting prisoner rehabilitation. Our aim is to reduce reoffending after release by providing prisoners with the right skills and support during their sentence, and by strengthening their ties with the community.

Today's visit was a great success, and we'd like to thank the Secretary of State for taking the time to meet our staff, and allowing them to demonstrate how outstanding results can be achieved through innovation, service excellence and teamwork.

## [Speech: Addressing Threat of Famine in Yemen](#)

Thank you very much indeed Mr President. I apologize also to Mark that a previous engagement delayed my coming into the Chamber, but thank you very much Mark for another sobering briefing.

It is very good that the UN can report swiftly to the Council in line with Resolution 2417, whenever the risk of conflict-induced famine and widespread food insecurity in armed conflict contexts occurs. In that Resolution 2417, this Council expressed its intention to give its full attention to such information the Secretary-General provides. As we all know on the Council, Yemen has been one of those issues that the Council follows very deeply and is gravely concerned about. I am pleased to see the Ambassador has joined us today.

The numbers you have cited Mark are truly horrifying. The scale is of very grave concern and the fact that the crisis does not seem to be getting better is also something that the Council needs to take a deep interest in.

The figures, I won't repeat them, but the fact that they are in the millions ought to be very salutary for us to think about. And the acute malnourishment of nearly 2 million children under the age of five in particular is a warning call. I understand that nearly 400,000 of those children suffer from severe acute malnutrition and that's a life threatening condition and it requires urgent treatment.

The highest number of severe acute malnutrition cases is in Hodeidah governorate – some 100,000 cases. After airstrikes in late July resulted in the damage of the main sanitation facility and water supply, suspected cholera cases almost doubled and that of course increases the risk of a new wave of cholera. Only the humanitarian response is containing an outbreak like last year's and a further disruption of humanitarian operations could have, as Mark said, catastrophic consequences.

Mark – you asked for increased funding and more support to humanitarian operations. Those efforts from the UAE and the Kingdom of Saudi Arabia are welcome. For the UK, we are determined to play our part. On World Food Day on 16 October, the United Kingdom announced a package of over \$125 million, which we hope will help UNICEF tackle malnutrition in Yemen.

But funding alone will not be enough to address the growing risk of famine. We need urgent action by all parties on the economy, imports and access, and protection of civilians and civilian infrastructure.

Mr President, I wanted to highlight four issues in particular.

Firstly, about the economy: We share the concern about the rapid depreciation of the Yemeni Riyal. Soaring prices putting several basic commodities out of reach for many Yemenis and the central bank struggling to pay public-sector salaries. We look to the Government of Yemen and the Central Bank to take urgent action to stabilise the Riyal – for example by issuing promised letters of credit to Yemeni commercial food importers. Until that happens, we also suggest that the Government of Yemen pause implementation of Decree 75, which is preventing staple goods such as wheat, cooking oil and rice getting into the country at a time when they are most needed.

Secondly, unhindered access for commercial and humanitarian food and fuel into and throughout Yemen is essential if famine is to be avoided. The

conflict is cutting off important transport routes, including the main route between Hodeidah and Sanaa and alternatives become more congested and more vulnerable. For their part, the Houthis must stop interfering with the humanitarian response so that food, fuel and medicines reach those most in need throughout the North.

Thirdly, it is essential that military operations be conducted in accordance with international humanitarian law. This includes protection of civilians and it includes protection of civilian infrastructure. We have consistently made this clear in the Council, but I repeat it again today. Not only is it important that military operations proceed with regard to the principles of proportionality, precaution and distinction, it is also the case that further damage to food infrastructure, such as mills and wheat silos threaten already fragile food supplies.

Fourthly and lastly, as we have made clear – only a political settlement will enable the worsening humanitarian crisis to be properly addressed and will bring long-term stability to Yemen. We call on all parties to engage constructively and in good faith with UN Special Envoy's efforts to bring about a political settlement. We look forward to hearing from Martin Griffiths again in this Council. We last heard from the Special Envoy on 11 September following disappointing news from Geneva. We support his efforts which have continued since then, and we look forward to further update in the coming weeks on progress towards reaching agreement between the parties on confidence-building measures and a broader framework agreement.

On the four points that Mark has made – some of which I have covered now – I think they deserve very urgent consideration by the Council.
