Mrs Sylvia Lam Yu Ka-wai

and to Deputy Director of Architectural Services in September 2016 before being appointed as Director of Architectural Services in December 2017.

## Mr Raymond Lee Kai-wing

Mr Lee joined the Government as Assistant Town Planner in May 1985 and was promoted to Chief Town Planner in March 2001, to Government Town Planner in May 2010 and to Principal Government Town Planner in June 2013 before taking up the position as Director of Planning in November 2016.
