Pending manslaughter in Sha Tin

Police are investigating a pending manslaughter case in Sha Tin yesterday (June 9) in which a 76-year-old man died.

At about 10.45am today (June 10), Police received a report in which a 76-year-old man collapsed after being pushed to the floor in an elderly home in Kwong Sin Street yesterday. Sustaining head injuries, he was rushed to Prince of Wales Hospital and was subsequently certified dead at 6.15pm that day.

After initial investigation, Police arrested a 74-year-old man for manslaughter. He is being detained for further enquiries.

Post-mortem examinations will be conducted later to ascertain the cause of death of the deceased.

Investigation by the District Crime Squad of Sha Tin District is underway.

<u>Correctional officers stop person in</u> <u>custody attacking staff</u>

Correctional officers of Shek Pik Prison stopped a person in custody attacking an officer this afternoon (June 10).

At 12.09pm, the 58-year-old male person in custody suddenly turned emotional and attacked a correctional officer with his hand on the way to Dayroom. Officers at the scene immediately stopped him and called for reinforcement.

The correctional officer sustained injury to his chest during the incident, whilst the assailant reported headache and waist discomfort. After examination and treatment provided by the medical officer at the institution hospital, both the officer and the assailant were transferred to a public hospital for further treatment.

The Correctional Services Department has referred the incident to the Police for investigation.

The assailant was sentenced to imprisonment for the offence of shooting at any person with intent to cause grievous bodily harm.

Eastern District Council by-election turnout (as at 4.30pm)

As at 4.30pm today (June 10), 2 639 of the 8 728 registered electors of the Kai Hiu Constituency had cast their votes in the Eastern District Council by-election, representing a turnout of 30.24 per cent. (The voter turnout figures are only for temporary reference.)

The two polling stations at Chinese YMCA of Hong Kong-Chai Wan Centre and Siu Sai Wan Community Hall will remain open until 10.30pm.

A dedicated polling station has been set up at Chai Wan Police Station for electors in the Kai Hiu Constituency who are remanded or detained by law enforcement agencies other than the Correctional Services Department (CSD) to cast their votes. The polling hours are from 7.30am to 10.30pm.

Electors in the constituency who are imprisoned or remanded in the CSD's custody can cast their ballots at four dedicated polling stations set up at their respective penal institutions. For security reasons, the polling hours are from 9am to 4pm.

<u>SWD to invite applications for 21st</u> <u>batch of Support Programme for</u> <u>Employees with Disabilities</u>

The Social Welfare Department (SWD) will invite employers of persons with disabilities to submit applications for the 21st batch of the Support Programme for Employees with Disabilities (SPED) from tomorrow (June 11) until July 20.

To support the employment of persons with disabilities, the SWD launched the SPED in June 2013 to provide employers of persons with disabilities with a one-off subsidy for each employee with disabilities for procurement of assistive devices and/or workplace modifications. The programme seeks to assist employees with disabilities in discharging their duties in the workplace and enhance their work efficiency.

The subsidy is capped at a maximum support level of \$20,000 for each employee with disabilities. Starting from 2014-15, a grant of up to \$40,000 may be considered for deserving cases for which the price of a single item of assistive device and its essential accessories exceeds \$20,000.

A wide range of assistive devices and workplace modifications which cater to the special needs of employees with disabilities at the workplace will be considered. Examples include computer accessories or adaptive equipment, optical magnifying devices, hearing and assistive devices, Braille products and handrails.

The Po Leung Kuk has been commissioned to serve as the SPED Administrator. It will assist in administering and promoting the SPED, provide advisory services and follow up on the progress of the subsidised programmes, prepare assessments on the applications and make recommendations to the Committee on the SPED set up by the SWD for consideration. Employers may apply for a subsidy under the SPED through nomination of the following referring organisations:

- non-governmental organisations (NGOs) operating SWD-subvented vocational rehabilitation services;
- NGOs running training courses for persons with disabilities or persons recovering from work injuries with the funding support of the Employees Retraining Board;
- 3. the Selective Placement Division of the Labour Department;
- 4. the Vocational Training Council; or
- 5. the SPED Administrator (the Po Leung Kuk).

Employers may submit their completed application forms together with the required documents by mail or by hand to the SWD through the referring organisations. No application fee is required and each applicant may submit more than one application.
