

# Update on dengue fever

The Centre for Health Protection (CHP) of the Department of Health today (January 5) reported the latest number of dengue fever (DF) cases, and urged the public to maintain strict environmental hygiene, mosquito control and personal protective measures both locally and during travel.

From December 29 last year to yesterday (January 4), the CHP recorded one imported DF case. The patient had been to Sri Lanka during the incubation period.

As of yesterday, one imported case of DF had been recorded in 2024. In 2023, 62 imported cases of DF were recorded.

The latest surveillance data shows that there is an increase in DF cases noted in some places in Asia (such as Bangladesh, Malaysia, Taiwan and Thailand) compared to the same period last year. Members of the public, while travelling abroad, should stay vigilant and carry out effective mosquito prevention and control measures. "Apart from general measures, travellers returning from areas affected by DF should apply insect repellent for 14 days upon arrival in Hong Kong. If feeling unwell, seek medical advice promptly and provide travel details to the doctor," a spokesman for the CHP said.

The public should take heed of the following advice on mosquito control:

- Thoroughly check all gully traps, roof gutters, surface channels and drains to prevent blockage;
- Scrub and clean drains and surface channels with an alkaline detergent compound at least once a week to remove any deposited mosquito eggs;
- Properly dispose of refuse, such as soft drink cans, empty bottles and boxes, in covered litter containers;
- Completely change the water of flowers and plants at least once a week. The use of saucers should be avoided if possible;
- Level irregular ground surfaces before the rainy season;
- Avoid staying in shrubby areas; and
- Take personal protective measures such as wearing light-coloured long-sleeved clothes and trousers and apply insect repellent containing DEET to clothing or uncovered areas of the body when doing outdoor activities.

DEET-containing insect repellents are effective and the public should take heed of the tips below:

- Read the label instructions carefully first;
- Apply right before entering an area with risk of mosquito bites;
- Apply on exposed skin and clothing;
- Use DEET of up to 30 per cent for pregnant women and up to 10 per cent for children\*;
- Apply sunscreen first, then insect repellent; and
- Re-apply only when needed and follow the instructions.

\* For children who travel to countries or areas where mosquito-borne diseases are endemic or epidemic and where exposure is likely, those aged 2 months or above can use DEET-containing insect repellents with a DEET concentration of up to 30 per cent.

## [Lands Department issues 12 pre-sale consents in fourth quarter of 2023](#)

The Lands Department (LandsD) announced today (January 5) that 12 pre-sale consents for residential developments involving 5 285 residential units were issued in the fourth quarter of 2023.

Details of the above residential developments (three of which being phased developments) with pre-sale consents issued are as follows:

Taking into account the pre-sale consents issued in the first three quarters in 2023, the LandsD issued a total of 39 pre-sale consents for residential developments involving 21 258 residential units in 2023.

As at December 31, 2023, 23 applications for pre-sale consent for residential developments involving 10 345 residential units were being processed. Details are as follows:

In addition, three applications for consent to assign involving 976 residential units and one non-residential unit as well as three applications for pre-sale consent for non-residential developments were being processed.

Members of the public can obtain up-to-date information on consents issued for the past quarter and cases pending approval by visiting the LandsD's website ([www.landsd.gov.hk](http://www.landsd.gov.hk)).

Intending purchasers are advised to study carefully the details of the development and the sale procedures, through information available from public advertisements, sales brochures and price lists released by the developer, before making a deposit for purchase. The sales brochure for a development also contains a summary of the provisions of the Deed of Mutual Covenant, including information on the common parts, the number of undivided shares assigned to each unit, the term of years for which the manager is appointed, the basis on which the management expenses are shared among the owners of the units, as well as a summary of the provisions of the government land grant, which intending purchasers are recommended to read carefully.

## [Refined arrangements for issuing Certificate of Particulars of Vehicle](#)

The Transport Department (TD) said today (January 5) that the Government has completed the review on the process of issuing the Certificate of Particulars of Vehicle (the Certificate). The TD will implement the following refined arrangements from January 8 onwards:

(A) The TD will state the purposes of establishing the register of vehicles (the Register), which are:

- (1) regulating the use of vehicles;
- (2) enabling the law enforcement agencies to discharge their responsibilities; and
- (3) providing relevant information to persons directly affected by the ownership or use of a vehicle who as a result need to ascertain the particulars of that vehicle.

(B) In accordance with the purposes for which the Register is established, the TD will specify the conditions under which it will only issue the Certificate as follows:

- (1) The applicant is the registered owner of the vehicle; or
- (2) The applicant declares that he has obtained the written consent of the registered vehicle owner concerned to acquire the relevant Certificate, and that such information would only be used for purpose(s) as specified in the written consent of the registered vehicle owner concerned. The applicant must also state to the TD the identity document number/Certificate of Incorporation Number/Company Registration Number of the vehicle owner, and such information provided should conform with the records maintained by the TD; or
- (3) The applicant declares that his (or his principal's) interests are directly affected by the ownership or use of the vehicle, and therefore needs to ascertain the particulars of that vehicle, and that such information would only be used for the following specified purpose(s), including:
  - (a) sale and purchase of vehicle;
  - (b) insurance claims;
  - (c) compensation/claims;
  - (d) rectification of improper presence of the vehicle;
  - (e) recover of fees/fines/charges and payment of loan involving a vehicle;
  - (f) legal proceedings involving the vehicle; and
  - (g) safety recalls.

(C) With respect to the application procedures, the TD will continue to accept both existing means of application by way of paper-based application forms or online submissions. At the same time, the TD will issue the "Guidance Notes on the Applications for a Certificate of Particulars of Vehicle" (the Guidance Notes) concerning the arrangements for the application for a Certificate, to provide details on the application procedures, the interpretation and examples of the specified purposes for which a Certificate could be issued, points to note, etc., for applicants' reference.

(D) In case the applicant considers that his application does not meet the aforementioned specified conditions but there is a need to ascertain the registered particulars of a vehicle due to other circumstances that involve the ownership or uses of the vehicle and significant public interest, and wishes the Commissioner for Transport to give special consideration for issuance of a Certificate, the applicant may make an application under exceptional circumstances through a written submission. The details of making

an application under exceptional circumstances are also available in the Guidance Notes. Paper-based application forms and online applications are not applicable to applications under exceptional circumstances.

(E) The TD or the law enforcement agencies may conduct checks on applications as necessary. The TD may also conduct random checks on applications within two years from the dates of issuance of the Certificates. Applicants are required to retain all relevant supporting documents/information during the aforementioned period, which may be subject to checking in the future.

(F) Starting from January 2021, the TD launched the email notification service for "the issue of the Certificate of Particulars of Vehicle" that allows individual registered vehicle owners to be notified when an applicant has obtained their personal data from the Certificate. Under the refined arrangements, the TD will extend the above service to all registered vehicle owners, including those registered in the name of companies. In cases where the TD has issued a Certificate of a vehicle registered in the name of a vehicle owner who has subscribed to the service, the TD will notify him by email that a Certificate has been issued for an application concerning a vehicle registered in his name and set out the details of the application concerned.

Upon implementation of the refined arrangements, the application process for a Certificate will be enhanced. The TD will be able to further minimise the risk of potential misuse or abuse of the information kept in the Register, and step up the protection of registered vehicle owners' privacy.

The details of the refined arrangements, the revised Form TD318 (Rev. 01/2024) and the Guidance Notes have been uploaded to the TD's webpage ([www.td.gov.hk/en/public\\_services/licences\\_and\\_permits/rovaioconvp/index.html](http://www.td.gov.hk/en/public_services/licences_and_permits/rovaioconvp/index.html)). The revised Form TD318 (Rev. 01/2024), as well as the Guidance Notes, will also be available from the TD's four Licensing Offices starting from January 8.

To accommodate the implementation of the refined arrangements, the arrangements for submission of applications for a Certificate are as follows:

(A) The online service for the application for a Certificate will be suspended from 5pm on January 5 to 8.59am on January 8 for system updates. The service will resume from 9am on January 8, accepting online applications; and

(B) The revised Form TD318 (Rev. 01/2024) will be in use starting from the implementation date of the refined arrangements, i.e. January 8. From January 8, the TD will only accept applications using the revised Form TD318 (Rev. 01/2024) (except for applications under exceptional circumstances). From January 8, if the existing version of the Form TD318 (Rev. 10/2019) is used for an application, the TD will not process the application and will return it to the applicant.

## [Hong Kong's latest foreign currency reserve assets figures released](#)

The following is issued on behalf of the Hong Kong Monetary Authority:

The Hong Kong Monetary Authority (HKMA) announced today (January 5) that the official foreign currency reserve assets of Hong Kong amounted to US\$425.5 billion as at the end of December 2023 (end-November 2023: US\$424.6 billion) (Annex).

There were no unsettled foreign exchange contracts at end-December 2023 (end-November 2023: US\$0.2 billion).

The total foreign currency reserve assets of US\$425.5 billion represent over five times the currency in circulation or about 40 per cent of Hong Kong dollar M3.
