### <u>Lifesaving services at beaches in</u> winter

The Leisure and Cultural Services Department (LCSD) announced today (October 31) the following arrangements for lifesaving services at its 39 gazetted beaches during the period between November 1, 2023, and March 31, 2024:

Deep Water Bay Beach, Clear Water Bay Second Beach, Silverstrand Beach and Golden Beach

November 1, 2023, to March 31, 2024 Lifesaving services available from 8am to 5pm daily

St. Stephen's Beach

November 1 to 30, 2023 Lifesaving services available from 8am to 5pm daily (Lifesaving services suspended from December 1, 2023, to March 31, 2024)

Repulse Bay Beach, Middle Bay Beach, Big Wave Bay Beach and Silver Mine Bay Beach

November 1 to 30, 2023, and March 1 to 31, 2024 Lifesaving services available from 8am to 5pm daily (Lifesaving services suspended from December 1, 2023, to February 29, 2024)

Stanley Main Beach

March 1 to 31, 2024 Lifesaving services available from 8am to 5pm daily (Lifesaving services suspended from November 1, 2023, to February 29, 2024)

Lifesaving services at the remaining 29 LCSD beaches will be suspended from November 1, 2023, to March 31, 2024, during winter. A detailed list can be found in the attachment.

The LCSD calls on members of the public to observe water safety while swimming. People should swim at the beaches only when lifesaving services are available. Please do not enter the water when the red flag is hoisted.

### LCSD's heated swimming pools open in

#### winter

The Leisure and Cultural Services Department (LCSD) will provide heated swimming facilities in 28 swimming pools under its management throughout the territory for public use during winter (i.e. November 2023 to March 2024) to enable more people to continue to exercise. The department calls on swimmers to keep public swimming pools clean and hygienic and mind their safety while swimming.

The list of swimming pools providing heated swimming facilities during winter can be found in the attachment. Of them, individual swimming pools will be temporarily closed during certain periods for maintenance works. Details are as follows:

Swimming pool	Period of temporary closure
Wan Chai Swimming Pool	December 1, 2023, to January 20, 2024
Kwun Tong Swimming Pool	January 2 to February 21, 2024
Sun Yat Sen Memorial Park Swimming Pool	February 1 to June 30, 2024
Victoria Park Swimming Pool	February 17 to April 17, 2024
Sham Shui Po Park Swimming Pool	February 25 to April 15, 2024

In addition, Tai Wan Shan Swimming Pool, which is without heated swimming facilities, will be open daily from 6.30am to noon from November 1 to 30, 2023.

Management Company Limited, Mr Simon Chan), Hendrick (Chairman of the Cyberport Investors Network Steering Group, Mr Hendrick Sin), Peter (Chief Executive Officer of the Hong Kong Cyberport Management Company Limited, Mr Peter Yan), distinguished guests, ladies and gentlemen,

Good morning. It is great to join you all at today's Cyberport Venture Capital Forum 2023.

Connecting the investment, technology and start-up community, this signature event of Cyberport takes pride in being a high-powered, thought-provoking and international forum of experts and stakeholders in innovation, technology and fund industries.

In the post-pandemic era, technological advancement moves at a lightning speed. Innovation and technology (I&T), as many would agree, is now the game changer of every sector. This inevitable phenomenon nicely echoes today's theme, "Venture Forward: Game Changing through Innovation".

Today, many economies have put in place proactive policies to promote technological breakthroughs and transformation. Hong Kong, of course, is no exception. Being one of our key I&T flagships, Cyberport has all along been a powerhouse in our vibrant ICT (information and communications technology) community. A few weeks ago, we were honoured to receive the delegation of the Ministry of Science and Technology from the Mainland and witnessed Cyberport's award as a State-level Scientific and Technological Enterprise Incubator since 2020, a recognition of Cyberport's sterling efforts and remarkable achievements in providing incubation and support services to the Hong Kong start-up enterprises.

Cyberport's achievements are also quantifiable. So far, the Cyberport community has attracted over \$36.7 billion of investment. Last year alone, Cyberport start-ups have raised more than \$1 billion of funding. Seven start-ups from this nurturing ground have acquired unicorn status, covering areas of fintech, smart living and digital entertainment.

But without your support, Cyberport could not have gone that far with flying colours. I&T development, start-up incubation, financing and long-term growth must come as one to make the whole ecosystem work. It is your passion and strong belief to realise the achievements of Cyberport and Hong Kong that we see today, and these will continue to redefine the game of today and tomorrow.
