Hong Kong Customs detects smuggling case valued at about \$6.9 million involving speedboat (with photos)

Hong Kong Customs on December 4 detected a suspected smuggling case involving a speedboat in the vicinity of Lau Fau Shan, Yuen Long. A batch of suspected smuggled goods, with an estimated market value of about \$6.9 million, was seized.

During the small hours on that day, Customs conducted an anti-smuggling operation in Lau Fau Shan and spotted a speedboat heading towards the waterfront. Later, several suspicious persons gathered at the waterfront were seen transferring a batch of goods from a metal hut onto a nearby sampan and were about to sail towards the said speedboat. They were suspected of engaging in smuggling activities.

Customs officers immediately took action, and the above-mentioned persons swiftly jumped onto the sampan and speedboat, and fled to Mainland waters.

Afterwards, Customs officers discovered inside the metal hut three plastic jerry cans with altered structures, filled with suspected smuggled electronic components and electronic devices.

During the operation, around 8 100 pieces of new electronic components and around 90 used mobile phones, with a total estimated market value of about \$6.9 million, were seized.

An investigation is ongoing.

Customs will continue to take stringent enforcement actions against cross-boundary smuggling activities through risk assessment and intelligence analysis.

Smuggling is a serious offence. Under the Import and Export Ordinance, any person found guilty of importing or exporting unmanifested cargo is liable to a maximum fine of \$2 million and imprisonment for seven years upon conviction.

DH's Shek Wu Hui Elderly Health Centre to be relocated to North District Community Health Centre Building from December 16

The Department of Health (DH) today (December 13) announced that the Shek Wu Hui Elderly Health Centre (SWH EHC) will be relocated to the eighth floor of the North District Community Health Centre Building, 3 Wai Wo Street, Sheung Shui, with effect from December 16 (next Monday) to continue to provide services for the elderly. The reprovisioned centre will be named the North District Elderly Health Centre. Service hours are from 8.30am to 1pm and 2pm to 5.30pm on Mondays to Fridays (except Saturday, Sunday and general public holidays).

The reprovisioned elderly health centre will provide a more spacious and comfortable environment that is convenient for wheelchair users and will help enhance the overall service standard. Clients who have made appointments at the SWH EHC will receive phone or SMS reminders reminding them to receive services at the new location.

There are currently 18 Elderly Health Centres in Hong Kong providing primary healthcare services to the elderly aged 65 and above on a membership

basis. Services including health risk assessment, health education, counselling and curative treatment are provided from a family medicine perspective using a multidisciplinary team approach.

The Civil Engineering and Development Department (CEDD) today (December 13) gazetted a notice to invite tenders for the contract for Hung Shui Kiu/Ha Tsuen New Development Area Second Phase Development – Contract 6 – Site Formation and Engineering Infrastructure Works (Contract No. YL/2023/06). The closing time for the tender is noon on February 21, 2025.

The works mainly include:

1. site clearance and formation (including land decontamination works) for about 62 hectares of lands, together with provision of associated engineering infrastructure;

 construction of district distributor and local roads connecting Hung Shui Kiu/Ha Tsuen New Development Area to Ping Ha Road and Ha Tsuen Road;
 construction of a sewage pumping station;

4. construction of associated works including water mains, drainage and sewerage works, cycle tracks, footpaths, box culverts, slope works, retaining structures, street furniture, landscaping works, electrical and mechanical works and other ancillary works; and

5. implementation of environmental mitigation measures (including noise barriers) and environmental monitoring works for the works mentioned above.

The works are scheduled to commence in mid-2025 and will take about 55 months to complete.
