# The EU adopts new actions to enforce rule of law in Jordan bringing the overall support to the country to nearly €2 billion

At the signing ceremony in Amman, Commissioner for European Neighbourhood Policy and Enlargement Negotiations Johannes **Hahn** said: "The EU has been a strong supporter of Jordan's justice reforms over a number of years, because, as His Majesty King Abdullah II has said, the rule of law is the guarantor of any individual and public rights, providing the effective framework for an efficient public administration and the basis for a safe and fair society. This  $\leqslant 50$  million programme takes EU support to Jordan since 2011 to nearly  $\leqslant 2$  billion of total financial support. The EU remains committed to keep supporting Jordan and its ambitious reforms at this difficult time".

### **Background**

The programme will contribute to enhance the independence, accountability and specialisation of the judicial power; support the improvement of caseflow management, effectiveness and information efficiency in the criminal justice chain; and contribute to improve the management and public service delivery in the Justice Sector.

This action is part of the EU's Annual Action Programme for Jordan that also includes actions in the field of trade, institutional capacity-building and social protection. Through this newly signed programme, the EU will support the Justice Reform Sector Strategy 2017-2021 in which the Government of Jordan has outlined actions to enhance independence, accountability and specialisation of the judicial power and improve the capacity and effectiveness of the judiciary administration.

The EU's action will build upon the existing programme with a continuous legislative and policy reform dialogue. It will provide up to €40 million in budgetary support of the sector reform from 2019 until 2022. An additional €10 million will support the implementation of measures by international development cooperation agencies (including the French AFD, the German GIZ and the Spanish AECID) to reinforce capacity-building arrangements, improve access to justice through enhancing the legal aid system and enhance legal cooperation.

This brings the total EU support to Jordan to nearly €2 billion of total financial support since the start of the Syrian crisis in 2011. This includes bilateral cooperation programmes aiming at enhancing Jordan's social and economic development, strengthening the rule of law, upgrading border management and preventing violent extremism. It also includes additional EU assistance mobilised to help Jordan institutions, host communities and Syrian refugees in Jordan to cope with the consequences of the Syrian crisis.

Jordan remains an essential partner for the EU at the global, regional and bilateral levels, in particular due to its important role in promoting stability in the region.

### 25 October: Launch of SELFIE, a new tool to support digital teaching and learning in schools

### The news:

On 25 October, Commissioner for Education, Youth, Culture and Sport, Tibor **Navracsics**, will unveil a new tool the Commission has developed to help all schools in the EU, Russia, Georgia and Serbia assess how they use digital technologies for teaching and learning. In the EU alone, the tool called will be offered to 76.7 million students and teachers in 250,000 schools on a voluntary basis. It is being launched in 24 EU languages with more language versions to follow.

### The background:

SELFIE (Self-reflection on Effective Learning by Fostering the use of Innovative Educational Technologies) is one of the 11 initiatives of the <a href="Digital Education Action Plan">Digital Education Action Plan</a> presented by the Commission in January this year. The Action Plan aims to boost digital skills in Europe and support the innovative use of digital technologies in teaching and learning.

The Commission has worked in partnership with ministries of education and a community of experts on digital education from across Europe to develop the SELFIE tool. Partner institutions include the <u>European Training Foundation</u>, the European Centre for the Development of Vocational Training (<u>CEDEFOP</u>) and UNESCO's Institute for Information Technologies in Education.

An early version of the tool was tested last year with 650 schools in 14 countries. This pilot produced 67,000 comments on how to further simplify and improve the tool — feedback that was integrated into the version launched

now.

### The event:

The launch is taking place today at a secondary school in Warsaw where the Commissioner is also attending the <u>eTwinning annual conference</u>. The Commissioner and the Polish Minister of Education, Anna Zalewska, are visiting the school to meet students and teachers and see how the school is embedding technology in learning.

# Declaration by the High Representative on behalf of the European Union on the recent developments on the case of Saudi journalist Jamal Khashoggi

After almost three weeks, facts are finally emerging, confirming that Saudi journalist Jamal Khashoggi was killed in the premises of the Consulate General of the Kingdom of Saudi Arabia in Istanbul on 2 October 2018.

The European Union expresses its deepest condolences to his family and friends and pays tribute to the memory of this respected journalist who was in direct contact for his work with many European institutions and organisations. We reaffirm our commitment to the freedom of the press and the protection of journalists across the world.

The emerging circumstances of Jamal Khashoggi's death are deeply troubling, including the shocking violation of the 1963 Vienna Convention on Consular Relations and particularly its Article 55.

Therefore the European Union, like its partners, insists on the need for continued thorough, credible and transparent investigation, shedding proper clarity on the circumstances of the killing and ensuring full accountability of all those responsible for it. The memory of Jamal Khashoggi, the family of the journalist as well as his friends deserve justice.
