

# Tender awarded for site in Tai Hang

The Lands Department announced today (December 18) that the tender for a site, Inland Lot No. 9076 at No. 135 Tai Hang Road, Hong Kong, has been awarded to the highest tenderer, Bright Vision International Limited (parent company: CITIC Pacific Limited), on a 50-year land grant at a premium of \$3,200,000,000.
