
## **SNP Indyref obsession failing Scotland**

21 Mar 2017



The Scottish Parliament has been diverted by a "pointless" two-day debate on independence — when it should be debating on key issues like the NHS and education, the Scottish Conservatives have said today.

The criticism was sparked following the SNP's decision for Holyrood to spend two days debating whether or not to have a divisive referendum rerun.

It comes amid further evidence that the Nationalist government is ignoring the day job over its own responsibilities.

The debate today comes as:

- For the sixth consecutive month, the NHS failed to meet the 95 per cent waiting time target set out by the Health Secretary Shona Robison.
- Only 54 per cent of muscoskeletal patients have been seen in the fourweek target timescale.
- Figures showed that Scots are drinking up to twice as much alcohol as they admit amplifying Scotland's unhealthy relationship with alcohol.
- The Scottish Chambers of Commerce warned that that the SNP "needs to begin focusing on mitigating business costs and boosting consumer confidence over the next two years."
- Reports revealed that the staffing numbers in schools are so low, students may be forced to learn from videos instead of qualified teachers.

### Scottish Conservative deputy leader Jackson Carlaw said:

"The pointless two-day debate has frustratingly delayed the potential to address issues that are in great need of being discussed.

"The SNP has continuously stated that it is not obsessed with independence, but its actions certainly show otherwise. "It's clear people don't want another referendum, they want a government that spends its every waking hour improving standards across all areas.

"When issues like health and education are crumbling under SNP leadership, Nicola Sturgeon and her party is completely failing Scotland by neglecting these issues and instead focusing on an unwanted referendum."

• Scots 'sick to death' of the SNP's independence games

The people of Scotland are "sick to death" of nationalist games on independence, Scottish Conservative leader Ruth Davidson has said.

Speaking as part of a marathon Holyrood debate on whether or not there should be a second independence referendum, she blasted both the SNP and the Greens for their "hypocrisy" on the issue.

She said the previous referendum was agreed legally and decisively under the Edinburgh Agreement, a process the SNP had described as the "gold standard" for referendums.

However, Nicola Sturgeon's latest attempts indicate a "tin pot approach", she said.

The First Minister announced last Monday that she wanted to hold a referendum re-run sometime between the autumn of 2018 and the spring of 2019, a timetable which has been rejected by the UK Government and the Scottish Conservatives.

And far from this being an attempt by the SNP to have a fair referendum, Ruth added, it was instead part of a "well-rehearsed game" to stoke grievance between Scotland and the rest of the UK.

### Scottish Conservative leader Ruth Davidson said:

"Most people in Scotland are sick to death of the SNP's games.

"They don't want another referendum any time soon, just three years after the last one.

"But let's cut to the chase: the SNP's plan was not actually about trying to hold a fair, legal and decisive referendum.

"It was about a well-rehearsed game to put forward unworkable proposals, wait for Westminster politicians to point that out, then rush to any nearby microphone — angry face attached — to trot out the same old tired complaints.

"This bull-dozer approach is completely at odds with the way the 2014 referendum was held.

"The UK and Scottish governments worked together on proposals for a fair, legal and decisive referendum.

"The Edinburgh Agreement was then signed — with both sides promising to respect the result.

"How different things are today."

## <u>Green lies on referendum re-run</u> <u>exposed</u>

The Greens' election manifesto will be deemed a "lie" if the party sides with the SNP in backing a second independence referendum, the Scottish Conservatives have said.

A series of remarks from the party and its "co-convener" Patrick Harvie have revealed a massive u-turn in recent months.

The information was compiled by the Scottish Conservatives ahead of a two-day

Holyrood debate on whether or not there should be a second independence referendum.

Following the No vote of 2014, Mr Harvie said Scotland should "live with" the result and "find ways to work together".

A month later, he added the country should "move beyond" the independence debate, and failing to do so would be "damaging".

The Greens also set out in their Holyrood manifesto that one million people should have to sign a petition, and that public demand should be "irresistible", before another vote was called.

In May last year, Mr Harvie said there would be "little point" in revisiting the poll unless opinion had shifted "markedly".

Most tellingly, the manifesto stated: "If a new referendum is to happen, it should come about by the will of the people, and not be driven by calculation of party political advantage."

However, since the turn of the year, the Greens' position has completely changed.

The party's own campaign, under the banner of Yes 2, has already begun, while just two months ago Mr Harvie said the independence option "has to remain on the table".

The Greens' vote is expected to be crucial, with their MSPs compensating for the lack of an SNP majority.

#### Scottish Conservative MSP Annie Wells said:

"The Greens like to think they're a bit different, and above the idea of manifesto pledges and hypocrisy.

"But they aren't, and these wild contradictions expose that.

"They were elected on a promise they would only back another referendum if the people wanted it.

"But that now looks like a lie, and it will be confirmed as such if they back the SNP on holding another unwanted and divisive referendum."

After the referendum, Patrick Harvie said that Scots would have to 'live with' and 'move beyond' the result

• Harvie said that Scotland would have to 'live with' the referendum result. 'I knew whatever the result Scotland would have to live with it, and find ways to work together. That's not always easy for people with passionately held opposing views, and it's only possible when we see and acknowledge each other's humanity. Now the result is in, there are many bitterly disappointed Yes campaigners around the country. There's also more than a little glee on the No side. Well OK, fair enough; they feel the need to celebrate and I've no doubt I would too if the position was reversed' (*Daily Record*, 20 September 2014, <u>link</u>).

• He said that we have to 'move beyond' the referendum result and that it would 'damaging' to 'obsessively focus' on people being Yes and No voters. 'There are many people who are still very proud of being part of the 45 per cent who voted Yes. And there are some who are finding it difficult to accept it wasn't a win. But I think it's important to say that this dividing line between the 45 per cent and the 55 per cent is one that we are going to have to move beyond. Focusing too much on that is going to become increasingly meaningless. That dividing line is one that isn't relevant for us as individuals anymore and it isn't helpful for the party and I think it would be damaging for Scotland as well to obsessively focus on that dividing line for the future.' The Greens said that a future referendum should be reliant on 1 million people signing a petition rather than political parties doing a deal behind 'closed doors'

- Patrick Harvie said that a second independence referendum should wait until public demand for another one is 'irresistible'. 'Any government that wants to put another referendum forward to win it, would be well advised to wait until the public demand from outside of the proindependence movement is irresistible. I don't want to scrape by with 51 per cent. I want a clear and decisive choice to be made. If we went into another referendum right now that wouldn't happen.' (*Common Space*, 28 May 2015, <u>link</u>).
- In a statement on a second referendum, the Greens asserted that the timing of a referendum should be based on 'public appetite' and they cited 1 million people signing a petition as a way of showing this. 'The timing of the referendum should be determined by public appetite: Scotland should decide, when Scotland wants to decide..... In assessing public appetite for a second referendum we will respect new kinds of citizen-led initiatives for example, a call for a referendum signed by up to 1 million people on the electoral register.' (Scottish Greens, 18 September 2015, link).
- Patrick Harvie demanded that the public be responsible for calling another independence referendum, not political parties 'carving up a deal behind closed doors'. 'The question of independence may well be put again, but let's say that the people of Scotland are in charge of that. We propose a citizens' initiative so that it is the public who say when they are ready for that question to be put, not political parties carving up a deal behind closed doors.' (*STV*, 10 October 2015, <u>link</u>).
- He said there would be 'little point' in a second referendum unless opinion shifted 'markedly'. The Scotsman reported that 'Harvie said there would be 'little point' in having another referendum unless opinion had shifted 'markedly' towards independence. 'Will that happen?

I hope so, I don't know'. (*The Scotsman*, 14 May 2016, <u>link</u>).

- The manifesto on which Scottish Green MSPs were elected said that another referendum should be called on the 'will of the people' rather than the 'calculations of party political advantage'. It had no other triggers for Green support for a second referendum. 'Citizens should be able to play a direct role in the legislative process: on presenting a petition signed by an appropriate number of voters, citizens should be able to trigger a vote on important issues of devolved responsibility. As we proposed on the one year anniversary of the Independence Referendum, this is the Scottish Greens' preferred way of deciding to hold a second referendum on Independence. If a new referendum is to happen, it should come about by the will of the people, and not be driven by calculations of party political advantage' (*Scottish Green Manifesto 2016*, p36, link).
- Patrick Harvie said that Brexit would not be the 'strongest context' to convince Scots to vote for independence. 'Greens support independence. I don't think we're ever going to argue against that position. What I have argued is that those on the pro-independence side who have almost seemed to be relishing the prospect of that Brexit scenario would be well advised to think carefully. I don't think it's the strongest context within which to continue to build the case that convinces those who weren't convinced of independence. I've no doubt at all that if that scenario takes place, there will be many who will demand another referendum. But I suspect they will already be the people who were convinced in 2014. They won't be the kind of people who felt uncertain in 2014 and those are the people that independence advocates need to engage with.' (Herald Scotland, 10 May 2016, link).

Now the Greens have broken their own promises by doing background deals with the SNP on a second referendum with little public appetite.

- Last summer, Patrick Harvie and Sturgeon had a backroom meeting on a second referendum. An SNP spokesperson said 'The plans for the SNP's new initiative on independence have had to take account of the EU referendum outcome. However, our campaign will be launched before the end of the summer recess and we look forward to working with others across the Yes movement to build majority support for independence.' (*The National*, 17 August 2016, <u>link</u>).
- The Greens have already begun to campaign under the banner of 'Yes 2' and would do so 'regardless of what the SNP is doing'. A party spokesperson said 'Ahead of our conference in October we will be announcing to our members proposals for relaunching the Green Yes campaign.' (*Express Online*, 10 August 2016, <u>link</u>).
- Harvie is pushing for a second referendum to be held in March 2018. 'What's been very clear is that the option needs to remain on the table, and we support that. That means the legislation to allow Holyrood to make that decision has to be progressed this year.... I think a reasonable guess at the moment might be that if Scotland chooses to have this question put again, if the UK chooses to dig its heels in and refuses to

respect the way that Scotland voted to remain in the EU, then maybe at some point round about the halfway mark of the two-year Brexit negotiation period, or not long after that halfway mark, we might need to be in a position to put that question to the public. (*Herald Scotland* , 13 January 2017, <u>link</u>).

 Recent polling has shown that over two thirds of Scots are against a second referendum. A BMG poll for Mev Brown of 1,009 adults carried out between 23 and 27 February found that, when don't knows are removed only, 33 per cent of Scots support a second referendum (*Daily Express*, 6 March 2017, <u>link</u>).

The Scottish Conservatives will vote against the SNP government's plan to take Scotland back to an immediate referendum campaign.

Ahead of the two-day Holyrood debate, the party said a majority of Scots did not want a separation re-run, and it was the wrong course of action to take.

## Scottish Conservative leader Ruth Davidson said:

"The SNP's motion makes it clear that Nicola Sturgeon is determined to fire the starting gun on another divisive referendum campaign this week.

"At a time when we should be coming together as a country, it is the wrong course of action to take.

"A clear majority of Scots say they don't want to go through the uncertainty of another referendum at this time.

"Worse, Nicola Sturgeon wants to trigger an immediate campaign while still hiding the facts on independence, such as the currency, EU membership and the price tag it would entail.

"Nicola Sturgeon wants to set a date but she won't tell us the plan. It is utterly irresponsible.

"We all had a vote on our membership of the UK three years ago. The SNP promised to respect that result. Yet now Nicola Sturgeon is using Brexit as an excuse to take us back to the division and uncertainty of the past.

"We believe a referendum cannot happen while the Brexit process is being played out.

"And we believe a referendum should not happen when there is no public or political consent for it to happen.

"It is a reasonable and rational position to hold. Scotland is saying loud and clear to Nicola Sturgeon – now is not the time."

Ruth Davidson has today insisted that "the SNP is not Scotland" as a new poll has again shown a majority do not want another referendum and that support for separation has stalled.

The Scottish Conservative leader was speaking during an interview on the Andrew Marr show on BBC One this morning.

Ms Davidson said "many thousands" of people in Scotland were "so thankful" when the Prime Minister Theresa May refused to bow to demands from Nicola Sturgeon for a second referendum between Autumn 2018 and Spring 2019.

Her comments were made as a Panelbase poll for the Sunday Times and LBC put backing for a split at 44%, one point lower than the 2014 referendum.

Less than a third (32%) of voters want a referendum within the timescale set out by the First Minister on Monday, while 51% do not want a repeat poll in the next few years.

In the interview this morning, Ms Davidson said: "I have to tell people – the SNP is not Scotland, and they are acting against the majority wishes of the people of Scotland.

"I have just read far too many headlines that Scotland reacts to X and

Scotland reacts Y and it doesn't.

"There are people across Scotland, many thousands of them, that are so thankful for the Prime Minister to actually say, let's take a pause on this."

Ms Davidson added that, after a two-day party conference in Aberdeen this weekend, the SNP have provided no further answers to key questions about an independent Scotland.

She said; "We have asked basic questions on things like currency, on things like a central bank, on things like whether we would even rejoin Europe as a full member, and Nicola Sturgeon seems unable to commit to that."
