We are following reports of multiple peaceful protests by Iranian citizens in cities across the country. Iran's leaders have turned a wealthy country with a rich history and culture into an economically depleted rogue state whose

chief exports are violence, bloodshed, and chaos. As President Trump has said, the longest-suffering victims of Iran's leaders are Iran's own people.

The United States strongly condemns the arrest of peaceful protesters. We urge all nations to publicly support the Iranian people and their demands for basic rights and an end to corruption.

On June 14, 2017, Secretary Tillerson testified to Congress that he supports "those elements inside of Iran that would lead to a peaceful transition of government. Those elements are there, certainly as we know." The Secretary today repeats his deep support for the Iranian people.

## **Press Releases: Kosovo Assembly Attempts to Abrogate Law on the Specialist Chambers**

The United States is deeply concerned by recent attempts in the Kosovo Assembly to abrogate the law on the Specialist Chambers, the court established to hear cases of alleged crimes against humanity, war crimes, and other serious crimes committed during the 1998-2000 conflict. We call on political leaders in the Republic of Kosovo to maintain their commitment to the work of the Chambers and to leave the authorities and jurisdiction of the

court unchanged.

As Secretary Tillerson said December 21, the pursuit of justice in the Balkans is not over, and we remain committed to supporting justice for the victims. We applaud the moral courage of the Kosovo political leaders who enacted the law and constitutional amendment in 2015 that enabled this court to be established. We strongly urge Kosovo's current political leaders and Assembly members not to undo that achievement by tampering with the court now or in the future.
