Update on dengue fever

The Centre for Health Protection (CHP) of the Department of Health today (October 11) reported the latest number of dengue fever (DF) cases, and strongly urged the public to maintain strict environmental hygiene, mosquito control and personal protective measures both locally and during travel.

From October 4 to 10, the CHP confirmed eight imported DF cases. The patients had been to the Philippines (three cases), India (one case), Indonesia (one case), Thailand (one case), Vietnam (one case) and multiple countries (one case, who had been to Malaysia and Singapore) during the incubation period.

As of yesterday (October 10), 165 cases had been recorded this year, as compared with 120 cases recorded in the same period last year. All the cases in 2019 were imported, mainly from Thailand (32), Malaysia (24) and the Philippines (22).

The CHP has been closely monitoring the latest DF situation in neighbouring and overseas areas. DF is endemic in many tropical and subtropical areas of the world. According to the World Health Organization, some Asian countries are experiencing unusually high numbers of DF cases for this time of year. The number of cases in several countries including Malaysia, the Philippines, Singapore and Vietnam was about two to six times the number for the same period in 2018.

According to the Health Commission of Guangdong Province, Guangdong is still in the epidemic season of DF. In Taiwan, as of yesterday (October 10), 510 cases (including 94 local cases) have been recorded in 2019.

â€<"Apart from <u>general measures</u>, travellers returning from areas affected by DF should apply insect repellent for 14 days upon arrival in Hong Kong. If feeling unwell, seek medical advice promptly and provide travel details to the doctor," a spokesman for the CHP said.

The public should take heed of the following advice on mosquito control:

- Thoroughly check all gully traps, roof gutters, surface channels and drains to prevent blockage;
- Scrub and clean drains and surface channels with an alkaline detergent compound at least once a week to remove any deposited mosquito eggs;
- Properly dispose of refuse, such as soft drink cans, empty bottles and

boxes, in covered litter containers;

- Completely change the water of flowers and plants at least once a week. The use of saucers should be avoided if possible;
- Level irregular ground surfaces before the rainy season;
- Avoid staying in shrubby areas; and
- Take personal protective measures such as wearing light-coloured longsleeved clothes and trousers and apply insect repellent containing DEET to clothing or uncovered areas of the body when doing outdoor activities.

DEET-containing insect repellents are effective and the public should take heed of the tips below:

- Read the label instructions carefully first;
- Apply right before entering an area with risk of mosquito bites;
- Apply on exposed skin and clothing;
- Use DEET of up to 30 per cent for pregnant women and up to 10 per cent for children*;
- Apply sunscreen first, then insect repellent; and
- Re-apply only when needed and follow the instructions.
- * For children who travel to countries or areas where mosquito-borne diseases are endemic or epidemic and where exposure is likely, those aged 2 months or above can use DEET-containing insect repellents with a DEET concentration of up to 30 per cent.
