

# Volume and price statistics of external merchandise trade in October 2021

Further to the external merchandise trade statistics in value terms for October 2021 released earlier on, the Census and Statistics Department (C&SD) released today (December 16) the volume and price statistics of external merchandise trade for that month.

In October 2021, the volume of Hong Kong's total exports of goods and imports of goods increased by 13.1% and 9.1% respectively over October 2020.

Comparing the first ten months of 2021 with the same period in 2020, the volume of Hong Kong's total exports of goods and imports of goods increased by 21.3% and 20.1% respectively.

Comparing the three-month period ending October 2021 with the preceding three months on a seasonally adjusted basis, the volume of total exports of goods and imports of goods decreased by 3.2% and 3.4% respectively.

Changes in volume of external merchandise trade are derived from changes in external merchandise trade value with the effect of price changes discounted.

Comparing October 2021 with October 2020, the prices of total exports of goods and imports of goods increased by 7.8% and 8.2% respectively.

As regards price changes in the first ten months of 2021 over the same period in 2020, the prices of total exports of goods and imports of goods increased by 4.5% and 4.6% respectively.

Price changes in external merchandise trade are reflected by changes in unit value indices of external merchandise trade, which are compiled based on average unit values or, for certain commodities, specific price data.

The terms of trade index is derived from the ratio of price index of total exports of goods to that of imports of goods. Compared with the same periods in 2020, the index decreased by 0.3% in October 2021 and 0.1% in the first ten months of 2021.

Changes in the unit value and volume of total exports of goods by main destination are shown in Table 1.

Comparing October 2021 with October 2020, double-digit increases were recorded for the total export volume to Taiwan (31.6%), India (28.5%), the USA (19.0%) and the mainland of China (the Mainland) (10.2%). Concurrently, the total export volume to Japan also increased by 2.5%.

Over the same period of comparison, the total export prices to all main

destinations increased: Taiwan (13.4%), the Mainland (10.5%), India (5.0%), the USA (2.5%) and Japan (1.3%).

Changes in the unit value and volume of imports of goods by main supplier are shown in Table 2.

Comparing October 2021 with October 2020, double-digit increases were recorded for the import volume from the Mainland (15.4%) and Taiwan (13.2%). Concurrently, the import volume from Singapore (5.4%), Korea (4.2%) and Japan (3.8%) also increased.

Over the same period of comparison, the import prices from all main suppliers increased: Taiwan (15.4%), Korea (13.9%), Singapore (9.9%), the Mainland (9.3%) and Japan (3.3%).
